
Kate Offenberger, DJFS Director, Leann Cline, Health Department Director, and Carol Risaliti, Prescription Assistance Network (PAN) Executive Director, appeared before the Board to discuss the PAN. This is a collaborative charitable pharmacy program that is now being offered in Stark County. This program exists from receiving their pharmaceuticals by donations. There are qualifications that you have to meet. Ms. Risaliti advised that they do have contracts with pharmacies. Ms. Risaliti advised they would like to bring this program into Carroll County. If we collaborate with agencies in Carroll County this process should be easy. They also have

connections with manufactures. Commissioner Wirkner asked if there was a local pharmacy or would they have to go to Stark County. Ms. Risaliti advised that they would need to go to Stark County at first. If this program would build in Carroll County, we may be able to have a pharmacy run here with the medicine prepared and delivered to the Health Department. Commissioner Wirkner asked if the Health Department would be the one handling the medicine. Ms. Cline advised yes. Ms. Offenberger advised the Health Department and DJFS would be willing to help process applications. Commissioner Wirkner recapped saying Stark County is making this available to Carroll County residents and the Health Department will be the ones to help with this process. Commissioner Wirkner advised from what he can see more people would qualify for this program than what would be expected. Commissioner Wirkner asked the news reporters if they would print the qualifications for this program. Commissioner Wirkner advised this program is great and will help the working residents that are unable to meet their deductibles. Ms. Risaliti advised this will also help underinsured. Ms. Risaliti advised they want to serve and this is an excellent pharmaceutical service. Sara Klein, Mr. Thrifty, asked if there is a list of approved medicines. Ms. Risaliti advised there is medicine from every classification, but they do not do controlled substances. Commissioner White asked what it would take to open a location in Carroll County. Ms. Risaliti advised you would have to have a pharmacist and the Stark County location was able to be opened from a grant. Commissioner Wirkner asked if the program is welcomed here and builds, then the Stark County pharmacy would fill the prescription, then it would be delivered to the Health Department and the Health Department would handle the medicine. Commissioner Wirkner advised that this is one of the most beneficial programs that have come through here in a long time. Hopefully, this will work. Commissioner White agreed. Commissioner White asked how this was going to be promoted in Carroll County. Ms. Offenberger advised there are pamphlets and an intern handing out flyers. Commissioner Wirkner advised DJFS is the perfect situation to get the word out. Ms. Offenberger advised the State of Ohio is going to a new Medicaid system. The spend down program for Medicaid is going to be eliminated. So, these residents will be a direct referral to this program. Commissioner White asked how the Commissioners can help. Ms. Offenberger advised we would like it to be in the paper. Ms. Risaliti advised that in Stark County, Commissioners gave them community development money. They also received a grant from the City of Canton and the City of Alliance. This helps compensate for expenses. Nancy Schaar, Free Press Standard, asked what this program costs. Ms. Risaliti advised that people value what they pay for. We have a donation structure in Stark County. If they are unable to pay, that is fine. Ms. Klein asked when the program will begin in Carroll County. Ms. Risaliti advised they are able to take referrals now. They can call PAN at 330-445-1087.
