The time having arrived to hold the public hearing for the approval of the Carroll County Subdivision Regulations as requested by the Regional Planning Commission, the following were present: Tait Carter, Regional Planning; Jeffrey L Ohler, Commissioner; Robert E Wirkner, Commissioner; Thomas R White, Commissioner; Nancy Schaar, Free Press Standard; Sara Klein, Minerva News Leader; Jeff Hawk, Augusta Township; and Christopher R. Modranski, Assistant Clerk I. Tait Carter advised there are two changes in the subdivision regulations. Mr. Hawk advised Augusta Township did not approve the changes because the township feels that the regulations should be guidelines and not regulations. Commissioner Ohler advised he thinks some townships are getting confused with subdivision regulations and the comprehensive plan. Commissioner Ohler advised the subdivision regulations are laws under the Ohio Revised Code and they have to be followed. The comprehensive plan is just a vision or a guideline. Ms. Carter advised section 5.102 is amended by removing the first paragraph and changing the chart from 65,340 square feet to 36,000 square feet for a single family sewer and 65,340 square feet to 50,000 square feet for a two family sewer. Also, paragraph A added that all widths are to be measured at the required building setback. Section 5.305 be amended by changing paragraph 1A to read permanent dead-end streets or cul-desacs shall be used only when a continuous street is not practical. Such a street should be no longer than 800 feet including the turnaround area of with there is 50 feet of right-of-way without parking and 60 feet of right-of-way with parking. A T-type turnaround may be used if the street is less than 350 feet and only residential. Commissioner Ohler asked if there were any comments or questions on the changes. Hearing no questions or comments Commissioner Ohler closed the public hearing.
