Josh Long, Dog Warden, appeared before the Board to discuss implementing an owner surrender policy. Mr. Long advised the public is under the assumption that if they have a dog that is licensed in Carroll County they can surrender that dog to the Dog Pound. Mr. Long advised he can only take in a surrendered dog if room is available. Mr. Long advised he does have a wait list for surrenders. Mr. Long advised people want to surrender dogs that are older and approaching the end of their life. Mr. Long stated that pet owners are surrendering their dogs so they don't have to incur the costs associated with owning an older dog such as vet visits or euthanasia. Mr. Long advised he does not want the dog pound to be a dumping ground for dogs to be euthanized. Commissioner Wirkner advised there is one downside with this policy and that is instead of them bringing the dog to the pound they will just dump them out on the street. Mr. Long advised he has researched with other counties and most accept surrenders based on adoptability. Commissioner Ohler advised he would look at that pet owner not as being compassionate but as trying to save a buck because if that pet owner doesn't have the heart to euthanize their dog they aren't going to have the heart to dump them on the side of the road. Mr. Long explained neighboring dog pounds charge a fee to accept surrendered dogs. Commissioner Wirkner advised he is not opposed to a reasonable fee if it isn't so high that it encourages an owner just to dump the dog on the road. Commissioner Ohler asked what the average cost is for euthanasia. Mr. Long advised it depends on the size of the dog, but costs are between \$100-\$200. Mr. Long advised that Stark County charges \$50.00 and Tuscarawas County charges between \$50.00 -\$150.00 depending on the dog's adoptability. Commissioner Ohler advised he feels that \$50.00 seems reasonable to him. Commissioner Wirkner feels \$50.00 is too high and suggests a \$25.00 fee.

Mr. Long reported the booster shot costs \$8.00 and the new license fee is \$14.00. Mr. Long advised there are a lot of man hours spent with each dog trying to locate owners. Mr. Long would like to micro-chip every dog that is adopted out of the Carroll County facility just as most other dog pounds and dog rescues are doing. Mr. Long explained the process for inserting the micro-chip into a dog and explained it will be something done inhouse. Mr. Long explained the micro-chip when scanned will reveal owner information and data about the dog which takes a lot of man hours out of the job. Mr. Long advised the scanners cost \$375 each and one would be needed for each truck and the micro-chips cost \$9.99 a piece for the first shipment and if you order a minimum of 100 micro-chips they include two scanners at no additional cost. Mr. Long advised the micro-chips have a long shelf life, and after the first shipment of micro-chips the cost increases to \$11.99 each.
