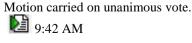

This RFP was sent to eight potential suppliers with requested term lengths ending May 2019, May 2020, and Many 2021 to commence on the November 2018 meter read (December 2018 bill period). Eight suppliers responded to the initial RFP. Refreshed pricing was requested from Dynegy, MidAmerican Energy Services, and the current supplier, Engie. Mr. Snavely advised that Palmer Energy Company recommends executing an agreement with Dyney for the term ending in May 2021.
