Judge Gary Willen, Municipal Court, appeared before the Board to provide an update on the Community Based Corrections Subsidy Grant through the State of Ohio, Department of Corrections. Judge Willen advised the grant has been in effect for two years now and because of its success they are giving an extension to this grant. Judge Willen advised the grant will be for Fiscal Year 2018 and 2019 which runs (July 1, 2017 to June 30, 2019). Judge Willen explained the grant is for \$82,200 and will be used for providing electronically monitored house arrest also known as ankle bracelets. Judge Willen advised he has issued ankle bracelets previously and the advantage to the County is the cost savings in jail days. Judge Willen advised that over the last two years we have saved 3,550 bed days at \$55.00 per day which totals over \$195,000 in savings to the County. Judge Willen explained that the average cost of an ankle bracelet is about \$450 for 30 days. Judge Willen asked the Board to consider the addendum to Community-Based Corrections Program 408 Subsidy Grant Agreement.
