**WHEREAS**, Ohio Regional Development Corporation, the Consultant, is a consulting firm with experience in applying for and administering CHIP Grant Programs throughout the State of Ohio, and was selected via the RFQ/P process to act as the consultant for Carroll County in applying for and administering the PY 2018 CHIP Program for Carroll County;

WHEREAS, it is necessary for the Grantee and the Consultant to enter into an Agreement which sets forth the responsibilities and expectations of each party for the PY 2018 CHIP Program;

WHEREAS, OCD Policy 15-02, 2 CFR 200.320, and the Partnership Agreement authorizes the Grantee to hire an administrative consultant, on behalf of the partnership, and those services are detailed in this contract for administrative services;

**WHEREAS**, Grantee and Consultant understand this agreement is contingent on PY 2018 CHIP funding from the State of Ohio, Development Services Agency, Office of Community Development (OCD);
