Vicky Moore, Carroll County resident, appeared before the Board to discuss issues with Frontier phone service. Commissioner Wirkner advised the policy of this Board is to discuss issues within its authority and ability to help. Ms. Moore explained she has had numerous complaints about Frontier's service for both her residential and business line. She has had dropped DSL, static, echoes and clicking noises on the line. Ms. Moore also described a day when the Sheriff's office knocked on her door after receiving a 911 call. Lt. Cheryl Keyser, 911 Coordinator, was also in attendance and explained that a 911 call came in showing an 868 number which was associated with Mr. and Mrs. Moore's address on Clover Road. Lt. Keyser investigated and found the number was never associated with the Moores. Frontier deleted the number from its database since it was a disconnected number and did not belong to anyone. Ms. Moore advised her concern was that this was an actual 911 call from somewhere, and law enforcement went to her home instead of the emergency location. Lt. Keyser advised Frontier described this as a phantom in their trunk lines. Commissioner Wirkner advised the County is transitioning into Next Generation 911. He explained the coordinates will be embedded in the call so this problem should not be an issue in the future. Commissioner Wirkner advised the Board is aware of the lack of internet in some areas and have been working for a number of years to fix the issue. Commissioner Wirkner instructed Ms. Moore to contact the Public Utilities Commission of Ohio (PUCO) if she is not satisfied with Frontier's response in regard to her other complaints. Ms. Moore asked if Commissioners can file a complaint with PUCO on behalf of Carroll County residents because she feels she is not the only one experiencing these problems. Commissioner Wirkner advised he would have to check with legal counsel; he explained the Board's relationship with Frontier is the same as Ms. Moore's – the Board is a customer and Frontier provides a service.

All residents are able to get in and out of their homes by going another route. Mr. Cottis expects the water to remain through the end of the week before subsiding. This may change if there is additional precipitation.


