RESOLUTION NO. 2018-15



Matt Campbell, Superintendent, Carroll County Board of Developmental Disabilities (CCBDD), appeared before the Board to discuss a levy renewal for CCBDD. Mr. Campbell advised CCBDD currently serves 314 individuals (Early Intervention, 45; Preschool, 77; School-Age, 42; & Adults, 150). Mr. Campbell advised CCBDD has a total cost of all Medicaid Waiver service plans for FY2018 of \$6,789,966.26 which encompasses 99 individuals. Mr. Campbell explained that if the service plans remain the same for FY2018,

Medicaid would pay about \$4,255,000, the State of Ohio would pay about \$1,890,000 and the CCBDD would pay about \$644,000. Ray Heaston, Business Manager, stated there around 15 agencies and several independent providers in Carroll County certified through the Ohio Department of Developmental Disabilities to provide and fulfill the services needed for these Medicaid Waiver individuals. All together, they employ 230 jobs in Carroll County. Mr. Heaston said if Medicaid would decrease their funding by 1%, CCBDD's match would increase by \$52,000. Mr. Campbell stated they currently have 81 individuals on the waiting list for services. Mr. Campbell advised CCBDD is seeking a renewal of their 10-year, 3.6 mil operating levy. Commissioner Ohler asked Mr. Campbell to elaborate on the individuals currently on the waiting list. Mr. Campbell stated those individuals have requested to be on a waiting list for services in the future but many of them aren't ready yet nor meet the requirements for Medicaid Waiver funding. Mr. Campbell provided the Board with a letter of programs and statistics. A copy of that letter is on file in the Commissioners' Office.

RESOLUTION #2018-15

A RESOLUTION DECLARING THE NECESSITY TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION

ORC 5705.19, ORC 5705.191, ORC 5705.25, ORC 5705.26

The <u>Board of Commissioners</u> of <u>Carroll</u> County, Ohio, met in <u>regular</u> session on the <u>31st</u> day of <u>May</u>, 20<u>18</u>, at the office of <u>the Board of County Commissioners</u>, with the following members present: <u>Robert Wirkner</u>, <u>Lewis Mickley</u>, and <u>Jeffrey Ohler</u>.

Mr. Mickley moved the adoption of the following Resolution:

BE IT RESOLVED by the <u>Board of Commissioners</u> of <u>Carroll</u> County, Ohio, that:

Section 1. This Board determines and declares that the amount of taxes which may be raised within the ten mill limitation will be insufficient and that it is therefore necessary to levy a tax in excess of the ten-mill limitation for the benefit of the entire territory of Carroll County, Ohio, for the purpose of the operation of community programs and services authorized by County Boards of Developmental Disabilities (Carroll Hills Program), for the acquisition, construction, renovation, financing, maintenance, and operation of developmental disabilities facilities or for both of such purposes as authorized by Section 5705.222 of the Ohio Revised Code, at a rate not exceeding 3.6 mills for each one dollar of valuation, which amounts to thirty-six (36) cents for each one hundred dollars of valuation for ten (10) years, and which levy is a renewal of an existing levy of 3.6 mills.

Section 2. The question of approving the levy shall be submitted to the electors of <u>the entire territory of Carroll County, Ohio</u> at the election to be held on the 6^{th} day of November, 2018, and that said levy be placed on the tax lists of the current tax year, commencing in 2019, first due in calendar year 2020, in compliance with the provisions of ORC 5705.34, if a majority of the electors voting thereon vote in favor thereof.

Section 3. The Clerk of this Board is directed to certify immediately a copy of this resolution to the County Auditor of Carroll County requesting that the County Auditor certify to the Board the total current tax valuation of $\underline{\text{Carroll County}}$ and the dollar amount of revenue that would be generated annually by the $\underline{3.6}$ mill levy.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open in the public, in compliance with law.
