The Board of Commissioners of Carroll County, Ohio, met in regular session on the 11th day of June, 2018, at the office of the Board of County Commissioners, with the following members present: Robert E. Wirkner, Lewis A. Mickley, & Jeffrey L. Ohler.

Mr. Mickley moved the adoption of the following Resolution:

WHEREAS, on the 31st day of May, 2018, this Board adopted a resolution determining to submit to the electors of Carroll County, the question of levying a tax in excess of the ten-mill limitation, as described below, a copy of which resolution was certified to the County Auditor of Carroll County; and

WHEREAS, the County Auditor has certified to this Board that the total current tax valuation of Carroll County is \$900,920,130.00, and the dollar amount of revenue that will be produced annually by the millage stated below would be \$3,023,000.00.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Carroll County, Ohio, that:

Section 1. This Board desires and determines to proceed with the submission to the electors of the question of levying a tax in excess of the ten-mill limitation for the benefit of the operation of community programs and services authorized by County Boards of Developmental Disabilities (Carroll Hills Program), for the acquisition, construction, renovation, financing, maintenance, and operation of developmental disabilities facilities or for both of such purposes as authorized by Section 5705.222 of the Ohio Revised Code, at a rate not exceeding 3.6 mills for each one dollar of valuation, which amounts to thirty-six (36) cents for each one hundred dollars of valuation for ten (10) years, and which levy is a renewal of an existing levy of 3.6 mills.

Section 2. The question of approving the levy shall be submitted to the electors of Carroll County, Ohio at the election to be held on the  $6^{th}$  day of November, 2018, and that said levy be placed on the tax lists of the current tax year, commencing in 2019 first due in calendar year 2020 in compliance with the provisions of ORC 5705.34, if a majority of the electors voting thereon vote in favor

Section 3. The Clerk of this Board is directed to certify a copy of this resolution to the Board of Elections of Carroll County, Ohio, not less than ninety days before the election, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open in the public, in compliance with law.

Ms. Leggett explained the only way for employees and visitors in the upper level to get to the lower level is to walk outside around the building and down the hill and vice versa. Not only is it a pain to have to go outside to get from one level to another, there was one workers' compensation claim from a fall and there have been other falls without injury. Ms. Leggett advised Mr. Eick found some alternate blueprints for the building which show inside steps in the back, right corner of the building (if you're entering the lower level). Mr. Eick suggests meeting with the Health Department to determine if the space is available for inside steps. Mr. Eick feels the maintenance involved for outside steps and the liability to keep snow and ice clear makes inside steps a better choice. Ms. Campbell is in favor of the inside steps and has vacant offices to move staff around to make the space work. Ms. Campbell advised her only concern is whether having stairs installed would require attention to handicapped accessibility from one floor to another. Ms. Leggett advised both upper and lower levels have accessibility from outside. Mr. Eick will research this concern.
