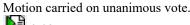

It took five minutes or more for people to clear the building, and two people sat in the jail area during the entire drill. Employees questioned whether they needed to leave and the terms used by our observers to describe everyone were "complacent" and "annoyed". Some offices on the Courthouse side said the alarm was not very loud. One of the most concerning things reported to Ms. Leggett was

that employees did not assist visitors out of the building. The observer on the first floor stood near the vending machines the entire time and not a single employee assisted him.
