Carl Mangun, Augusta Township Trustee, Dick Thompson, Augusta Township Trustee, and Chris Rotonda, Brown Township Trustee, appeared before the Board to discuss the Magnet Road slip along Stillfork Creek. Mr. Mangun advised there is about 220 feet of roadway falling into the creek and about \$60,000 has been spent trying to fix it over the last year and a half. A geological study was done and the recommendation was to put in a retaining wall. Muskingum Watershed Conservancy District (MWCD) has awarded them a \$300,000 grant, but the total cost of the project is \$390,000. Brown Township and Augusta Township agreed to contribute \$5,000 each and they expect additional costs including an engineering firm to draft certified drawings to bid the project. Mr. Mangun advised the EMA may have some funding available, but he is asking the Commissioners to consider contributing to the project. Mr. Mangun explained 27 residents live on this road. The options are to repair the road with a retaining wall or to close that section of road which would landlock two houses to the point they could not access their homes from the bridge to the slip area. Mr. Mangun said the road dropped over 21 inches since June, and they hauled in over 200 ton of stone to bring it back to level. Brian Wise, County Engineer, told Mr. Mangun that adding more weight in the form of stone or asphalt will just make the problem worse. Mr. Mangun explained if the road is closed, ambulances will have to go around and access the residents via Arrow Road which will add about 15 minutes to the response time – and that is why the EMA funding may be available. Mr. Mangun said if other funding is not secured, there is no other option but to close that section of road. Commissioner Wirkner advised the Board will not know what the County's budget will look like until funds are certified by the Auditor, but he does not foresee \$70,000 being available. Commissioner Mickley agreed. Mr. Rotonda asked if there is a timeline they can give to MWCD. Commissioner Wirkner asked Auditor Lynn Fairclough when certification can be expected. She said the third week of December. Commissioner Mickley asked if a loan was possible. Mr. Mangun advised a loan is not an option because Augusta Township would not be able to pay it back, especially since they already have a loan payment on a truck and townships are limited on how much they can borrow through Ohio Revised Code. Mr. Rotonda said Brown Township cannot proceed with a loan either. Commissioner Wirkner suggested the Townships contact Tom Cottis at the Carroll County EMA office to see if he knows of any funding available and to also contact the Prosecutor to inquire about a loan between two political subdivisions. The Township Trustees will return to the Commissioners on January 7, 2019.

Janice E. Leggett, Commissioners' Clerk Supervisor, appeared before the Board to discuss preservation of the Commissioners' Journals. Ms. Leggett advised the journals date back to the 1800s and are relied upon for research into many issues like road establishments and road vacations. She explained the journals are required to be kept permanently and, to her knowledge, there is no microfilm or other back-up copy of them. Ms. Leggett reached out to the clerks listserve and the records listserve of which she is a member and was provided with some companies to contact. In preparation for today's meeting, Ms. Leggett asked one company for a ballpark estimate to preserve the 37 large journals and 14 legal size journals which contain about 600 pages each. The estimate was \$10,000.00 which includes microfilm and pdf. Ms. Leggett advised if that is accurate, there is funding left in salary lines since the office did not have an Assistant Clerk for a time this year. Commissioner Wirkner advised it has waited from 1833 to today so it can wait until the budget is reviewed. Commissioner Mickley agreed and felt it would be nice to have a digital version.

IN THE MATTER OF TELECOMMUNICATIONS SERVICE PRIORITY (TSP) PROGRAM PHONE REPAIRS



Janice E. Leggett, Commissioners' Clerk Supervisor, appeared before the Board to discuss the Telecommunications Service Priority (TSP) program through the Department of Homeland Security. Ms. Leggett explained she received an email from one of the Frontier representatives suggesting the County apply for this program. The program is for entities that support public health, safety and law and order activities. In the event of an outage, those offices will be given priority treatment to restore phone service. It does not have to be during a disaster; it can be a normal outage where Frontier will not dispatch someone for two days. We can use this service to get Frontier here immediately. Ms. Leggett applied for the Courthouse, EMA office, and Sheriff's Office to be in the TSP program. The request was approved but there are some additional steps to finalize the process and it will take about two months to complete. Ms. Leggett advised she is before the Board to request three things: (1) approval of the TSP program, (2) approval of the Frontier fees which include a one-time set up fee of \$14.50 with an additional \$4.90 per month per circuit, and (3) who should be added as authorized users of this service.
