Ms. Leggett opened the meeting and advised we did not have a quorum therefore she reviewed/advised about everything on the agenda.

OLD BUSINESS:

Ms. Leggett advised that we did receive our ParaPass – fare collection software and cards however it has not been implemented yet due to some questions. For example, we have an Amish School that pays for approximately 5 individuals to ride there however, we are not sure how to use the cards for these passengers since they would be under the school name and not the individuals. Also, we have some passengers that go to approximately 5 different locations which would mean they would need 5 different cards and it would be their responsibility to decipher which card is for which location. One suggestion for this was to possibly put a sticker on it with the location name. Mrs. Tonya Myers questioned if there was a place that a hole could be punched in the card to place it on a key ring, in which she believes it would be easier for the seniors to know where their card is. Ms. Leggett advised her and Vicky would get these questions answered because they need to get this up and running.

Ms. Leggett advised that ODOT has approved the rate increase of \$1.00/trip; trips over 40 miles one-way will be charged \$.35 an increase of \$.10 as well as trips that originate out-of-county and transport to Carroll County will be charged \$15/one way these rates became effective October 15th, 2018.

Ms. Leggett also advised that the OMEGA has presented the Coordinated Plan to the Commissioners and the next step is to get Board Approval so that it may be sent to ODOT for approval. Mrs. Myers advised she was present when OMEGA presented it to the Board and they did have some questions but would have to get

with Ms. Leggett. Mrs. Rinkes questioned what the Coordinated Plan is actually for and Mrs. Myers replied it is for local stakeholders to work together to provide transportation for those in need. Ms. Leggett advised there was a questionnaire put out for everyone to fill out to see what the transportation needs are in Carroll County and once the plan is approved we would begin working on those needs. Mrs. Myers advised one particular need they advised about was the marketing of transportation services throughout the county, and she stated since she has been doing the renewal for the Senior Center she has advised every time about the services they provide which include Carroll County Transit. Ms. Leggett advised once the Plan is approved she will get the committee a copy.

NEW BUSINESS:

Ms. Leggett advised the following:

- Recommendation for the TAC meetings for 2019 remain quarterly which would be January, April, July and October. We will vote on this in January at the next meeting.
- To have no changes in the contract for 2019 since they were just increased in 2017 and with the new rates for general public it would make it harder to see if there really needs to be an increase in contracts since it has only been a couple weeks.

OTHER BUSINESS:

Ms. Leggett advised the following:

• There are extended hours on Election Day that would be 6:00 am - 8:00 pm for anyone who wants to utilize it, but if they use it to go to polling locations, it is a "free" ride.

Ms. Leggett questioned if anyone had anything else to present to the committee, nothing was presented therefore the next meeting will be January 30, 2019 @ 9:30 at Carroll County Transit.
