# 2019 BUDGET - COMMON PLEAS COURT

Michael Repella, Common Pleas Judge-Elect, appeared before the Board to discuss the 2019 budget. Mr. Repella advised it is guesswork the first year, but he compared the 2017 actual expenses with the 2018 appropriations to arrive at his figures. He decreased the Salary-Employees line by \$30,000 in the Common Pleas budget. He knows he will have two staff and possibly a bailiff. Mr. Repella is considering just using the Probation office for bailiff duties. It's still up in the air. What increased was the foreign judge expense. Mr. Repella explained any pending criminal case and any civil cases for which he was involved cannot be heard by him as Judge. This is due to Mr. Repella's involvement in the cases through the Prosecutor's office or through his private practice. Mr. Repella reduced the supplies, increased equipment slightly, increased juror fees, reduced transcripts, and reduced travel. The Jury Commission was not changed. Mr. Repella explained the Adult Probation salaries line increased to give some cushion to hire another probation officer/bailiff to handle drug court. He expects to get grants for the drug court but even if he does not, he will still follow the submitted budget. So the grand total for the Common Pleas budget is \$493,131 which is about \$6,000 less than Judge Olivito's 2018 appropriations. Commissioner Ohler suggested Mr. Repella contact the Board after the first quarter to let them know all is OK or if there were any unexpected expenses. Mr. Repella has spoken with Municipal Court Judge Willen about working together on probation and improving the line of communication between the two courts.
