A meeting was held with the Board of Elections employees and Board members which included Deputy Director Amanda Tubaugh, Director Vickie Reed, Board Member Jeff Mangun, Board Member Georgette Huff, Board Chair John Barnett, and Board Member Robyn Sutton. Ms. Tubaugh provided the Board with a Cost Saving Analysis which details how the Board of Elections has saved \$437,025 since 2009. This total included programming of the ballot, logic and accuracy testing and handling IT support all in-house. Ms. Tubaugh explained she expects reimbursement for equipment of \$190,205 from the State and, taking into account some upgrades needed, she expects a total 5-year savings of \$95,730. Mr. Barnett thinks the new Governor and Secretary of State will be kind to counties in that he doesn't expect new mandates on the local level. Commissioner Wirkner stressed that any decisions made by the Board of Elections which will impact the General Fund or the operations of the Courthouse should be discussed with the Commissioners first. Commissioner Wirkner discussed the Attorney General Opinion (#2018-017 issued July 12, 2018) which he quoted, "...a board of county commissioners may, but is not required to, procure group health care insurance policies for county officers and employees...The language of R.C. 305.171 does not require a board of county commissioners to provide insurance, coverage, or benefits to all county officers or employees in a uniform manner." Commissioner Wirkner understands offering incentives to get Board of Elections members, but the Section 125 Plan states insurance benefits are not offered to part-time employees. Commissioner Wirkner advised there is a policy in place that General Fund employees contribute 15% for insurance, but at some point, the Board of Elections lowered that percentage to 11.5%, and just recently the Board of Elections voted to offer insurance to spouses. Commissioner Ohler agreed with Commissioner Wirkner that the Commissioners need to be aware of impacts on the General Fund and with consistency of insurance rates for all employees. Ms. Tubaugh asked if elected officials are permitted to insure spouses. Commissioner Wirkner referred to the Attorney General opinion and R.C. 305.171(A) saying, "...for full-time county employees and all county officers, except for members of the county board of elections, so long as the decision by the board of county commissioners to exclude members of the county board of elections is rationally related to a legitimate governmental interest and thus comports with the Equal Protection Clauses of the Ohio and United States Constitutions." Commissioner Wirkner explained the providing of insurance and the employee's contributions falls within the authority of the Commissioners. Mr. Barnett asked for a copy of the opinion to review as the Board of Elections was unaware of the opinion. Commissioner Ohler asked when the Board of Elections members began receiving insurance. Ms. Reed answered it was when she was hired the first time, and she was unaware of the Attorney General opinion. Ms. Tubaugh contacted the Auditor's Office who gave instruction to pass a resolution. Commissioner Wirkner said again the Commissioners are not under any obligation to underwrite any resolutions from the Board of Elections that spend money from the General Fund or obligate the General Fund. Commissioner Ohler's opinion is not to pay for the spousal insurance and the employee contribution should be 15% to match the rest of the General Fund.
