Commissioner Ohler advised this is the first year he remembers that there were not a lot of accounts to juggle and bring to a zero balance. Commissioner Wirkner advised the original budget requests totaled approximately \$10,057,000 and that was brought down to \$10,018,000 to start today. The certification of estimated receipts is now \$10,479,000. Commissioner Wirkner advised the Airport Authority grant of \$5,000 does not cover the real estate taxes so it really isn't a grant when the money comes right back to the County. Commissioner Ohler discussed Magnet Road and the added time it will take for emergency services to reach those homes. He feels the Board should consider granting funds to repair the road. Christopher Modranski, Commissioners' Assistant Clerk II, spoke with Carl Mangun, Augusta Township Trustee, who informed him they recently secured all the funding necessary to repair the road and no funds were needed from the Board. Commissioner Mickley advised the budget for Multi-County Juvenile District is only \$110,000 not \$181,000 as requested. Janice Leggett, Commissioners' Clerk Supervisor, said the Park District sent a letter requesting \$36,000 to install a warming kitchen and replace the roof of the barn. Commissioner Wirkner's opinion is the Board of Elections salary line should be their 2018 total with 3% added. The Board reviewed the salaries of the Board of Elections employees and opted to reduce the budget line for salaries. The retirement funds needed for the Board of Elections employee totaling almost \$12,000 will be removed from the Board of Elections budget and placed in Transfers Out to be transferred into the S095 General Fund Retirement. Commissioner Wirkner feels the fund for State reimbursements needs reviewed at some point to be sure the monies being reimbursed is put into the General Fund or the fund from which it originated. Commissioner Mickley asked if the Non-General Fund offices had been vetted. Ms. Fairclough answered yes. Commissioner Mickley questioned the request in Transfers Out for \$165,000. The Transfers Out funding should be increased to \$260,000 to account for \$153,000 for Permanent Improvement (with \$125,000 of that for the Bell Tower Project), \$15,000 for the Landfill, \$80,000 for the oil and gas monies owed to the County Home, and \$12,000 for the retirement. Ms. Leggett reviewed the changes discussed, and Commissioners agreed with the following:

Commissioner Ohler discussed the \$300,000 check received from Muskingum Watershed Conservancy District which will ultimately be put into Permanent Improvement to be used for the Bell Tower Project.
