Commissioner Ohler advised he has been thinking about the funding for the Bell Tower project and asked the Board to consider using emergency funds for the project and then transfer monies back into the account out of the 2020 budget. Commissioner Ohler advised the project is going to cost between \$500,000 and \$800,000 and the County cannot borrow money on an unsecured basis. Commissioner Ohler stated there are only two ways for the Board to borrow money and that is with general obligation or revenue bonds. Commissioner Ohler advised the banks he spoke with require those documents to be prepare by outside counsel. Commissioner Ohler will present more information to the Board as he gets it for further discussions. Commissioner Wirkner advised this was the first year that gas and oil royalties have been included in anticipated revenue. Commissioner Wirkner said that in the past it was not included and contributed to the County reaching anticipated revenue earlier than he feels will happen this year. Commissioner Wirkner explained the total estimated receipts for 2019 are \$7,225,601 and increases in conveyance fees, investment income, real estate taxes and gas and oil proceeds to allow for a more realistic picture of the anticipated income. Commissioner Ohler advised it still comes down to if we are comfortable borrowing the money. Commissioner Wirkner said that with the gas and oil taking a dip it may impact the revenue now since this is the first year it is included in the anticipated income. Commissioner Ohler stated that it won't affect the 2020 income because that money is based on the 2018 price. Commissioner Ohler stated he understands there is a comfort with having the \$500,000 in reserve. Commissioner Wirkner said it's a very comfortable feeling, it's our plan B, our fall back position. Commissioner Wirkner wants to make sure that all considerations have been carefully evaluated and we look at all angles.
