

Nancy Schaar, Free Press Standard reporter, then inquired about the Airport and if their goal was to get the Commissioners to pay for the removal of the trees and why they are involving the Commissioners. Commissioner Mickley responded that the question has been who has the authority to enforce the zoning regulations that were passed years ago. Commissioner Mickley reiterated that ultimately it is the landowner's responsibility to keep the trees or other obstructions out of the airport zoned space. The Airport is trying to work with the landowners to remedy the problem through a grant that would help with the cost of tree removal as an alternative to legal action. The zoning regulations set a \$100 per day per obstruction fine for obstruction in the air space. He stated one property has about 200 trees in the air space and they were notified two years ago so that really adds up. Ms. Schaar mentions an FAA inspection in 2014 noted the trees and how they hindered the visual approach. They said at that point the trees needed to come down or they could shut down the airport. Commissioner Wirkner adds the other option was to shorten the runway. Ms. Schaar continues saying one of the landowners bought property to specifically sell the timber and another will not even speak to anyone from the Airport. Commissioner Mickley stated most people are willing to cooperate except for the two previously mentioned landowners. Commissioner Mickley points out that the issue is the landowner bought a property in a zoned area that prohibits those trees and has not maintained that. Theoretically he could owe thousands of dollars in fines for those obstructions, which the Airport is willing to let go if the landowner permits access to the Airport to remove the trees at the Airport's expense. Otherwise, it will need to go to the next step and have a legal enforcement. Commissioner Mickley believes the push right now is the grant deadline, so they are trying to get people signed before the deadline. Commissioner Wirkner adds that the EMA will be including the Airport as part of the County's critical infrastructure and disaster services mitigation plan, which will allow the Airport more opportunities for grants and give the Airport a more meaningful role to the people in the county. Commissioner Ohler asked if the FAA was holding the Board of Commissioners responsible for the enforcement of the zoning regulations. Commissioner Mickley responds that the Ohio Revised Code states the Airport Zoning Board is responsible for the administration and enforcement of the zoning regulations, and the Code states clearly that the Board of Commissioners in a county acts as the Airport Zoning Board. Additionally, when the initial zoning regulations passed it was reflected in the Commissioners' minutes that the Carroll County Board of Commissioners act as the Airport Zoning Board. He states that one of the questions was had that duty been split at some point but he found no evidence that it had been. Commissioner Ohler asks if there is a timing issue in order to receive the grants. Commissioner Mickley responds that yes, the issue should be resolved as quickly as possible for the Airport to meet the grant deadline. He continues that there is a possibility that the Airport moves forward and leaves those property owners out, but they can only get the grant once and they want to include them as a show of good will and good faith. If they were to leave them out, then the landowners would be responsible for the cost of the tree removal.
