WHEREAS, the recent freeze-thaw cycle and unusually rainy weather in Carroll County and across Ohio have caused slips and road damage: and

WHEREAS, many municipalities in Ohio are currently facing significant clean-up and repair costs as a result of flooding, landslides and road slips and these unexpected events can devastate a community's already-lean budget; and

WHEREAS, eastern Ohio has seen growth and investment as a result of the Marcellus and Utica Shale drilling and extraction; however, this growth has outpaced the county and municipality budgets' ability to maintain and repair roads subject to an equally unprecedented increase in the amount of traffic, particularly heavy truck traffic; and

WHEREAS, the Ohio Department of Transportation's budget plan would increase the motor fuel tax by 18 cents per gallon with future increases indexed to consumer price inflation; and

WHEREAS, this action will help restore a strong partnership between the state and local governments in addressing the state's infrastructure needs; and

WHEREAS, the investment provided by an increase in the motor fuel tax is necessary to keep rural communities like those in Carroll County competitive to the oil and gas industry and is vital to attract and retain sustainable, diverse economic development; and

WHEREAS, reliable transportation budgets enable communities to expand and improve roads and provide for strategic planning that positions our communities to embrace economic opportunity and foster subsequent economic growth; and

WHEREAS, county governments are responsible for the maintenance and repair of over 26,000 bridges and 29,000 county road miles; and

WHEREAS, the state's motor fuel tax has not increased since early 2000.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Carroll County and the Carroll County Engineer, do hereby support increasing the motor fuel tax by 18 cents per gallon with future increases indexed to consumer price inflation, as proposed by the Ohio Department of Transportation.
