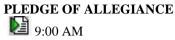

Janice Leggett, Loss Control Coordinator, appeared before the Board to discuss the safety of the Dog Warden and Assistant Dog Warden. She explained this is a subject she has been working on with little progress since late 2016 when Josh Long was promoted to Dog Warden. The first issue is if a Warden is off work and the other goes on a call, there is no one to check in with or monitor the Warden's absence. If the Warden gets in trouble, no one is going to know until he doesn't come home from work. Commissioner Wirkner asked if the trucks had MARCS radio capabilities and, if so, suggested the Wardens check in with Sheriff's dispatch for any call they feel is questionable or dangerous. Secondly, Ms. Leggett advised the Wardens have no protection against dogs or humans. They deal with both people and dogs in volatile situations the average person would not think would happen on a call about a dog. Ms. Leggett spoke briefly with Sheriff Williams about the Wardens joining in the Ohio Peace Officer Training Academy (OPOTA) training through his office for everything up to but not including firearms. She also spoke with Commissioner Wirkner who had no objection to the "force continuum" which he explained is a steady elevation of how an officer responds in a threatening situation. He gave the example of verbal commands to empty hands to non-lethal means of defense like pepper spray, batons, and tasers.

Commissioner Ohler asked if the Wardens could carry a shotgun. Commissioner Wirkner said there is a liability and training no matter what type of firearm they may carry, but that training includes the force continuum. Ms. Leggett advised CORSA provided a written opinion that the Wardens are permitted under Ohio Revised Code to carry firearms, but they highly recommended annual firearms training, a firearms policy, documented training and other things. Commissioner Wirkner advised the firearms training lasts three months. He suggested the Wardens start training for non-lethal weapons for self-defense. He stated policies and procedures need to be established for call-out situations and trainings, and it's time to actually do something. Commissioner Mickley stated he spoke with Warden Long about these issues over the last year and instructed him to bring trainings to the Board for approval, but he has not done that. Commissioner Wirkner said then it's time to handle it on the Commissioners' end.

Commissioner Wirkner explained in that situation, there should be a policy if the Warden does not have a gun, he should call for someone who does. Commissioner Wirkner will let the Sheriff know these policies are in the works. Commissioner Wirkner recalls a meeting where GPS was discussed to track the trucks, but nothing was done. He feels that is a good option so dispatch can monitor the Wardens. The Board also discussed the firearms training and the added liability of permitting a concealed-carry license.

Commissioner Ohler reviewed the Permanent Improvement fund balance of approximately \$400,000. Of that, \$52,000 is earmarked for Security and \$118,000 for the County Home with an additional \$67,000 tied up in purchase orders, leaving a balance of \$162,000. Commissioner Wirkner advised the carryover continues to decrease over the years, and he plans to send a memo to departments that the cash position is going in the wrong direction. Commissioner Wirkner stressed that the Rover Pipeline already paid for the year, so no additional funds will be coming. Commissioner Wirkner explained the budget is growing faster than revenue can support. A few of the contributing factors include health insurance, child services, and indigent defense. Commissioner Oher advised the bond is just pushing the obligation off for ten years, but he sees no other way. Janice Leggett, Commissioners' Clerk Supervisor, stated there is \$153,000 in Transfer Out ready to be moved into Permanent Improvement. Commissioner Ohler said there is \$645,997 in unappropriated funds but \$400,000 of that is set aside for the Board of Elections voting equipment. The Board discussed whether reimbursement checks had been received from the State but no one was sure if the checks had arrived yet. Commissioner Ohler explained there are projects other than the Bell Tower on the agenda and those include the 2nd Street steps (\$26,500), gravel for the Senior Center parking lot (\$15,000), Health Department parking lot (\$50,000), and Job & Family Services plumbing (\$25,000). Commissioner Ohler also spoke with Ed Eick, Maintenance Supervisor, who informed him the Sheriff is expecting renovations and repairs to the jail which could get into the range of \$800,000. Commissioner Ohler feels if the bond is \$1,000,000 then the payment will be about \$140,000 a year. Commissioner Ohler added the stair issue also needs addressed at the Health Department. Commissioner Wirkner said those entities that receive grants need to understand adjustments may be needed in 2020. Commissioner Ohler explained there was \$135,000 set aside for contingencies for the Route 9/171 Water & Sewer Project, and there is only about \$35,000 left.

IN THE MATTER OF **FRONTIER** PHONE/INTERNET

Commissioner Wirkner advised he has been negotiating with Frontier to get services to the new Sheriff's Office building and to increase the internet capacity. It has not been over 30 days and the project has gone nowhere. Commissioner Wirkner explained Frontier felt this was a marketing opportunity to force the Commissioners to commit to five additional years on the current contract. He told the Frontier representative to cancel the request for service at the Sheriff's building.
