Commissioner Wirkner advised that he had met with Judge Repella. Commissioner advised he has spoken with Sheriff Williams and Judge Repella with the possibility of the County entering in an agreement with the State. The State would provide the County $\$ 150,000.00$ if the County agrees to house Felony 5 individuals in the county jail in lieu of sending them to the State Prison. Commissioner Wirkner advised Judge Repella is looking into the details of this agreement. Commissioner Wirkner advised the County would receive $\$ 75,000$ per year for two years if the County agrees to house level 5 felons in the County Jail. Commissioner Ohler asked about the commitment of the State and after the two years, the County needs to live with what was received. Commissioner Ohler advised the County needs to look and see what the long-term impact on the Sheriff's budget is. Commissioner Wirkner advised that the program has been around for a while, and the County decided not to participate initially. Commissioner Wirkner advised that there are around 40 out of 88 counties that participate in the program. Commissioner Ohler asked if the compensation is greater for other counties. Commissioner Wirkner advised some counties are mandated to participate. Larger counties forced to participate while smaller counties have option to participate. Commissioner Wirkner advised the County needs to see whether it is beneficial to take the money or not. Commissioner Ohler advised not to enter in an agreement until all repairs to the courthouse and jail are completed so there won't be an issue of an influx of prisoners while repairs are being made. Commissioner Wirkner advised these prisoners are already in the county system. The County would have prisoners for around 6 months, and then send felony cases to the State, and if the County participates, then prisoners would stay in the County Jail instead of moving on. Commissioner Ohler advised to look at past years and see what the effect would have been. Commissioner Wirkner advised Judge Repella is looking into this. Commissioner Ohler advised the Board may not want to burden future commissioners after the two years is up. Commissioner Wirkner advised Sheriff needs to be involved in decision process. Commissioner Wirkner advised initially, the Sheriff wasn't supportive. The Sheriff felt it hampers the judge, because the judge may feel the prisoner needs to be in the state prison. Commissioner Wirkner advised, under the agreement, the cost is $\$ 72$ per day to send someone to the state prison. Commissioner Ohler question cost of staying in county jail. Commissioner Wirkner replied less than $\$ 72$ per day. Commissioner Ohler asked what examples of level 5 offenses are. Commissioner Wirkner advised a lot of drug offenses are level 5 felonies.
