Susie Frew, Manager of Community Health Outreach & Promotion, appeared before the Board to provide an update to the 2019 CEBCO Wellness Program and the 2020 CEBCO Wellness Program. Ms. Frew advised that there have been 52 employees and spouses who have completed the health evaluation and earned over 600 points. Those employees will receive 2 tickets into the drawing. There were 20 people who completed the health evaluation and receive 1 ticket for the drawing. Ms. Frew advised that once the final numbers come into CEBCO, she will hold a random drawing for the incentive prizes. Ms. Frew advised the number of employees who participated is down from the previous year. Commissioner Wirkner questioned about earning tickets for the drawing. Ms. Frew advised that employees need to earn 600 points through the interactive health portal. Ms. Frew advised that she is still waiting for the results to come back for those who have done different activities to earn points before holding the drawing. Commissioner Wirkner asked if it is possible to earn a 3rd ticket. Ms. Frew advised that, the way the employee benefits committee set up the program, two tickets is the most that an employee can earn. Ms. Frew advised that the Employee Benefits Committee approved to continue with the drawing and possibility to add a \$200 incentive to increase participation for 2020. Commissioner Wirkner advised that there is an increase in the CEBCO premiums and an increase in the Dental Coverage and isn't sure if there will be funds available

IN THE MATTER OF COMMUNITY HOUSING IMPACT AND PRESERVATION (CHIP) FAIR HOUSING PUBLIC HEARING



Dale Hartle, president of the Ohio Regional Development Corporation appeared before the Board to provide an update to the Community Housing Impact and Preservation (CHIP) and present information about Fair Housing. In fall of 2018, Carroll County was awarded a CHIP grant in the amount of \$402,700. Of that amount, \$212,700.00 is reserved for private owner rehabilitation, \$120,000.00 is reserved for home repair, and \$22,000.00 is reserved for Rental Assistance. Mr. Hartle advised that there have been two housing rehabilitations completed, another in the process, and one more is pending and is ready to go out to bid. The program has a goal of five owner housing rehabilitations for the grant cycle. Mr. Hartle advised that the state requires 50% of the program funds must be under contract by the end of November. Mr. Hartle advised that the county has already met that milestone. The state also


requires that the county needs to draw 25% from the grant which also has been met. Mr. Hartle advised that the county needs to complete nine home repairs and has already completed seven home repairs and have three home repairs pending. Mr. Hartle advised the program is moving along well. Mr. Hartle advised that Part of the housing grant is to provide information for Fair Housing. Mr. Hartle presented information about Fair Housing and provided Fair Housing and Tennant Landlord Facts literature. Commissioner Ohler questioned how much has been spent on the projects so far. Mr. Hartle answered that he doesn't have the amount for each project but will have his office provide that information. Commissioner Ohler asked if it is important to spend all the grant funding. Mr. Hartle advised that it is best that the grant is spent in the county and doesn't go back to the state. Mr. Hartle advised that that grant projects need to be completed by September of 2020. In the spring, Mr. Hartle's office will look at whether there is a need to move funds from the private rehabilitation account to the home repairs account. Mr. Hartle advised that not many communities have made the progress that Carroll County has made. Mr. Hartle advised that there is one rental repair with a cost of \$2,000.00 and one rental housing assistance. Commissioner Ohler questioned who does hiring of the contractors for the projects. Mr. Hartle advises his staff bids out to the three contractors and provides inspection of the work at least once a week. Mr. Hartle advised that the homeowner selects three contractors from list of qualified contractors. The homeowner can provide their own choice of contractors, but Mr. Hartle's office would need to verify their work. Commissioner Ohler advised he wishes that local contractors can do the work. Mr. Hartle agreed that it is best when a company from the community can provide the services for a CHIP project.
