Wirkner advised that the integrator will guarantee that the Text to 911 software will integrate with the county's equipment. Commissioner Wirkner answered Columbiana County, Harrison County, Morgan County and cannot recall the other two but can update the Board with their names. Commissioner Wirkner advised that the grant application is due in December and there is no guarantee the county will receive the grant. Commissioner Wirkner advised, without the grant, the cost will be \$40,000.00 to \$50,000.00 to get Text to 911 services.
