Commissioner Ohler questioned when Melissa Schaar, Assistant Clerk I is due to be removed from probationary status. Christopher Modranski, Clerk Supervisor advised that Ms. Schaar was not placed on probationary status when hired, but if treated as such, Ms. Schaar would be employed for six months around the end of November or beginning of December.
