This is an increase of 25% that has been received in the past. Commissioner Wirkner advised that this should be considered in planning next year's budget. Commissioner Wirkner advised that the county will receive 75% of indigent defense funds back as a reimbursement.

### IN THE MATTER OF **OPIOID LITIGATION**



Commissioner Wirkner advised that Governor DeWine is looking at a state-wide effort concerning the opioid litigation. One option the governor is looking at is creating a trust fund for any funds received from the opioid litigation. Commissioner Ohler advised that he saw something in the news about the opioid litigation. Commissioner Wirkner questioned Commissioner Mickley if he has any updates on the opioid litigation. Commissioner Mickley advised that it is a wait and see if the state takes over. The consensus is that a statewide takeover is not in the best interest of the counties, but it is the state that makes that decision. Commissioner Mickley advised that the settlement negotiation class has been finalized and negotiations should be taking place soon.

# IN THE MATTER OF ROVER PIPELINE



Commissioner Ohler advised that the auditor informed him that there is development with the Rover Pipeline. Commissioner Ohler advised that Rover wishes to revisit the formula for the ad valorem tax. Commissioner Wirkner advised that this was brought up during a session at winter conference. Commissioner Wirkner advised that when the Rover started to build the pipeline, there was an estimated value of building the pipeline. Rover is contesting that valuation. Commissioner Ohler advised that, in April of 2019, the county received about \$400,000.00 from the ad valorem tax. Commissioner Ohler advised that this was based on the construction of the pipeline, not on the value of product. Commissioner Wirkner advised that an assessment is needed to determine that value. Commissioner Ohler advised that some counties are taking the lead, and most auditors do not feel that Rover is overpaying. Commissioner Ohler advised that his concern is income from taxes next year could be less and impact the anticipated revenue for the 2020 budget.
