Sheriff advised that in his time as a deputy and then as Sheriff, he has never jailed an offender that had need of ADA compliant showers. Commissioner Ohler will be researching with the State but he believes that this issue can be resolved by having a contract or Memorandum of Understanding (MOU) with Tuscarawas County to house disabled prisoners. Commissioner Ohler advised that there are also issues with the door width, and distance between the toilet and the bars will not allow for changes to the door width. Commissioner Ohler advised that there are some changes that need to be decided with the lighting and the plumbing that he will

be working with the jail commission on. Commissioner Ohler advised that the first two days of the project will require all prisoners to be moved due to no water and sewer in the whole facility and will also affect the Sheriff's offices and 911 office on the other side of the Commissioners' office. After that, they will have to work with the contractor on which days all prisoners will have to be moved, and which days only some prisoners will have to be moved. Commissioner Ohler advised that since this is not a permanent improvement issue, the County cannot pay those relocation and traveling costs from the permanent improvement funds. Commissioner Ohler advised that those costs will need to be added to the budget, however there is no way to know exactly how much will need to be budgeted at this point. Commissioner Ohler advised that it is going to be very difficult to allocate money to non-mandated requests at this point. Commissioner Wirkner and Commissioner Ohler agreed that once the project is completed, then the Board will be able to re-look at non-mandated expenses.
