


Dale Alexander, Park District Director and Rick Hannon, Park Board of Commissioners President appeared before the Board to discuss the Park District 2020 Budget. Mr. Alexander advised that the levy did not pass. Mr. Alexander advised that the Park District was counting on levy for future expenditures. The Park District has cut 14% of the Community Park budget and 30% of the Bluebird Farm Park. Mr. Alexander advised that the Park District is looking for sponsors for concerts. At the Bluebird Farm, there is a need to maintain buildings, which includes repointing, re-glazing windows, and other repairs to maintain the integrity of the buildings. There is \$10,000.00 of electrical work that has been put off and needs addressed. At the Carroll Community Park, the restroom is almost completed. The Park District has been using part-time help and volunteers to save money on the project. Mr. Alexander advised that he plans to talk with soccer club and youth baseball that utilize the facility to see if they would be able to help. Mr. Alexander advises that the Park District will not be looking at another levy in 2020 but may seek a levy in 2021. Commissioner Wirkner questioned what the Park District is requesting. Mr. Alexander advised that the Park District is requesting \$75,000.00 to keep services running and make the repairs that are needed. Commissioner Ohler advised that Mr. Alexander talk with Stacy Taylor, Deputy Auditor to check about the grant budget line and make sure funds are placed in the correct account. Commissioner Wirkner advised that he doesn't see \$75,000.00 in the current budget. Commissioner Ohler advised that the Board will need to wait until the budget is finalized to see what the expected funds will be. Commissioner Ohler advised that there may be funds left over after the Jail Project has been completed. Some of those funds could be allocated to the parks board, but the Board will also need to do due diligence to reduce debt such as sheriff's radios and the bond payment for Bell Tower and Jail projects. Commissioner Ohler advised that the Park District will need to wait until budget is completed and have a better idea of what free funds are available for grants. Commissioner Wirkner advised that this year is different than other years. Typically, the Board can anticipate what expenditures will come up and will know what funds are available. Jail inspectors have been making requests for renovations of the jail which will require the jail to be shut down completely and will need to account for the housing and transfer of prisoners. Mr. Alexander questioned when the Board would know about what funds are available. Commissioner Ohler advised that he plans to seek for bids by end of February or mid-March. The engineer of the project expects that the project will last four months, with the completion around the end of June or beginning of July. Commissioner Ohler advised that, to save costs of transporting prisoners, the judge may use house arrest in lieu of housing inmates in the jail but will need judge's approval. The judge may also utilize video arraignment to save transport costs. Commissioner Wirkner advised that the Board would like to help with the form of a grant but will not be able to determine if possible until the project has been completed. Mr. Alexander advised that he will cut his budget through staff reduction and a reduction of services. Commissioner Ohler advised that the Board needs to account for unexpected expenses that may come up, which typically 5% of the budget is reserved for this. Commissioner Wirkner asked when Park Board can come back to see what funds would be available. Commissioner Ohler advised once the budget has been finalized, the Board will have a better idea of what funds are available. Commissioner Ohler advised that the Route 9 sewer project is another project that the county is responsible for and will have to pay. Commissioner Wirkner questioned if due diligence was applied in the negotiations. Commissioner Ohler advised that due diligence was applied, but he is unable to discuss the details of the negotiations. Commissioner Ohler advised that there were unexpected expenses during the project such as the moving of the unmarked cemetery, and AEP poles that needed moved. The costs were more than what was reserved for unexpected expenses. Lynn Fairclough, Auditor advised that her office will help the Park Board with their budget and payroll. Rick Hannon, Park Board President appreciates the Board's help but is concerned that the budget shortfall will be more than just one year. The Park District was established by the Ohio Revised Code but provided no mechanism for funding. Mr. Hannon asks for help with any grants that could be available for the Park District. Commissioner Wirkner advised that the Board will do all they can to help the Park District Board.
