WHEREAS, in order to maintain a balanced 2020 Budget, the Board of Commissioners is asking departments to reduce their expenditures; and

WHEREAS, one tool a department can use to reduce their expenses is to reduce hours worked by employees by utilizing either the SharedWork Ohio program or through layoffs; and

WHEREAS, the Board of Commissioners recognize the sacrifice that county employees are making when taking reduced work hours; and

WHEREAS, to show their gratitude, the Board of Commissioners offers to continue health insurance coverage to those who have had their work hours reduced by either participating in the SharedWork Ohio program or a layoff due to the COVID-19 Pandemic; **NOW THEREFORE, BE IT RESOLVED** by the Board of Commissioners, Carroll County, Ohio:

<u>Section 1:</u> Employees who have their hours reduced as a participation of the SharedWork Ohio program or who have been laid-off due to the COVID-19 Pandemic shall continue to receive health insurance coverage.

Section 2: The county shall continue to pay its share of the above-mentioned employee's health insurance, provided said employee continues to pay their share as well.

Section 3: This order shall be effective immediately through December 31, 2020.

IN THE MATTER OF HEALTH DEPARTMENT – COVID-19 UPDATE

🔰 9:10 AM

Dr. Wendy Gotschall, Health Commissioner appeared before the Board to provide an update on the COVID-19 Pandemic. Ms. Gotschall advised that there are 24 cases in the county, of those, 20 are confirmed and 4 are probable. Of the 24 cases, 19 have recovered. Ms. Gotschall advised that there have been 2 deaths associated with the COVID-19. Ms. Gotschall advise that Health Department has received \$35,000.00 allocated for contact tracing and monitoring. Ms. Gotschall advised that contact tracing and monitoring are normally done by the Health Department and not just with the COVID-19 crisis. Ms. Gotschall advised that the Health Department will do contact tracing with any Class A type of disease such as tuberculosis or sexually transmitted diseases. Ms. Gotschall advised that COVID-19 is no different, just on a larger scale. Ms. Gotschall advised that if the Health Department is notified of a positive case, they will contact that person and talk with them to see how they are doing and monitor their symptoms while they are home, so that if their symptoms get severe, the Health Department can get them to the appropriate health care provider. The Health Department will also contact those who may have been exposed to a confirmed patient. Ms. Gotschall advised that Health Department will advise them to monitor themselves because they may have been exposed to a highly contagious disease. Ms. Gotschall advised that the state has allocated additional funding for contact tracing because of the volume due to COVID-19. This funding will help with training for volunteers who will help the Health Department with contact tracing and monitoring. Ms. Gotschall advised that the Health Department received a \$45,000.00 grant for reimbursement due to COVID-19 related activities. The Health Department also received \$5,000.00 Coronavirus Response earlier. Ms. Gotschall advised that the Health Department is continuing to receive deliveries from the National Stockpile. They received 3 deliveries this week from National Stockpile. Ms. Gotschall advised that expect to receive a delivery tomorrow that is allocated for government entities such as the county, municipalities, and townships. Ms. Gotschall advised the Health Department will work with each entity as well with Tom Cottis, EMA Director to disperse the personal protective equipment (PPE) to each entity. Ms. Gotschall advised that the Health Department, with Mr. Cottis, has given out great deal of PPE throughout the county from the National Stockpile. Ms. Gotschall advised that that have given out gowns, face shields, surgical masks, gloves, and goggles to long-term care facilities, fire departments, EMS, law enforcement, and some businesses. Ms. Gotschall advised that testing will be a big topic on upcoming phone conferences with the Ohio Department of Health. Ms. Gotschall advised that the county has not received a lot of test kits. The county has received about 150 testing kits so far. Ms. Gotschall advised that the county has used 50 of those tests. These tests are scarce, so there is a priority for testing. The priority is hospitalized patients, congregate settings such as long term-care facilities, jails, group homes, or anywhere where there is a lot of people who live together, and health care workers who are symptomatic. Ms. Gotschall advised that the Health Department has partnered with Mercy Stat Care who has been collecting samples. Ms. Gotschall advised that the Health Department has been working with area businesses to help them meet the guidelines from the state. Ms. Gotschall advised that Health Department wishes to work collaborative with businesses to come up with creative solutions. Ms. Gotschall advised that they have received calls from a lot of businesses, churches, and various groups asking for the Health Department to come out to help with reopening. The Health Department does not want to have a heavy hand approach with these policies. Ms. Gotschall advised that the Sheriff offered to go out with the Health Department when visiting businesses, but the Health Department does not want that type of approach. Ms. Gotschall advised that if they hear a business not complying with the orders, the Health Department will go out and help the business, such as giving masks for employees. Commissioner Wirkner asked when widespread testing will be available in the county. Ms. Gotschall answered it is a matter when materials will be available. She advised that they should have more info either today or tomorrow.
