IN THE MATTER OF **HIRING FREEZE**



Commissioner Wirkner advised that the Board needs to discuss adopting a hiring freeze and what conditions would apply. Commissioner Ohler advised that general fund departments, whether internal or outside of the courthouse, will have no funds available to be allocated for the addition of any new staff. Commission Ohler advised that the hiring freeze should state that there are no funds for additional staff. Commissioner Ohler advised that if an employee would leave the county, then it would be appropriate for the office holder to provide the Board with documentation that said employee is essential to be replaced. Commissioner Mickley advised that he agrees with Commissioner Ohler's suggestions and added that he feels the Board should recommend not hiring people unless it is a supervisory position. Commissioner Mickley advised that there should also be language that allows for things such as the poll workers in November. Commissioner Wirkner advised that he sees 3 basic take outs from this discussion. One, a motion to freeze new hires. Two, if an essential worker needs to be replaced, the office holder or department head will need to provide written documentation to the Board as to why employee needs replaced. Commissioner Ohler advised

that the only exception to the rule for a new hire would be if the office holder feels it is essential to bring the new employee on board, the Board will support that however the office holder will need to realize that their salary line will not change. Commissioner Ohler advised the department will have to make cuts to their budget to accommodate the new salary. Commissioner Wirkner advised that makes sense, except that means there is no longer a freeze in place, unless the Board is to consider new hires on a case by case basis with discussion between the Commissioners and the office holder. Commissioner Ohler advised that possibly the Board needs to clarify that by saying that any exceptions must be approved by the Board. Commissioner Wirkner advised that he feels there will be no approval by the Board if it includes any increase in the salary line because that is the purpose of a hiring freeze. Commissioner Ohler advised that he does not want to take away the ability to hire a person that they feel is essential from the office holder. The Board will likely approve the hire, but not an increase in the salary line. Commissioner Wirkner advised that the last thing is to establish a timeline for the freeze. Commissioner Ohler advised that the hiring freeze will be in effect until the financial emergency is behind us, and there is no way to know how long that will be. Commissioner Ohler advised that he would like to name this period of financial emergency the Fiscal Crisis.
