Commissioner Ohler advised that he had received a message from Bill Wohlwend, Clerk of Courts about the Courthouse hours. Commissioner Wirkner advised that even thought the Commissioners did adopt a resolution to limit the hours of public access to the Courthouse, the judges also signed an order limiting the hours.

IN THE MATTER OF **HEALTH DEPARTMENT**



9:19 AM

Kelly Engelhart, Director of Nursing appeared before the Board to provide an update on the COVID-19 health crisis. Ms. Engelhart advised that there are 21 confirmed and probable cases. Of those, 18 have recovered. Ms. Engelhart advised that the age range is from 7 months to 98 years. Ms. Engelhart advised that of the 21 cases, 29% have chronic lung disease, 90% have a symptom of a cough, and 81% have a symptom of a shortness of breath. Ms. Engelhart advised that they are seeing asymptomatic transmission occurring with the confirmed and probable cases. Ms. Engelhart advised that the outbreak in the long-term care facilities has been under control. Ms. Engelhart advised that they have tested 38 residents and heath care workers from 3 different long-term health care facilities. Ms. Engelhart advised that they monitored 65 residents or healthcare workers, and most are off the quarantine period. Ms. Engelhart advised that they are still monitoring 15 individuals. Ms. Engelhart advised the Health Department are continuing their weekly conference calls with the long-term care facilities. The have had 100% participation this past week and now include any congregate facility. The St. John's Villa and the convent are now included. Ms. Engelhart advised that the Health Department is working on increasing the tests from the State Department of Health and are working with LabCorp to provide testing for those who do not meet the Department of Health's criteria for testing. Ms. Engelhart hope that these tests will be available for local health care providers. Ms. Engelhart advised that the Health Department is asking for volunteers to help in two different roles. The first are being called disease detectives. They will help with identifying and monitoring positive patients' contacts and those who may have been exposed. The second are safety scouts. They will be working with local businesses by evaluating safety plans for compliance with the Governor's orders. The Health Department has asked local businesses to show how they plan to meet the different requirements. Once those plans have been reviewed, they will be posted on the Health Department's web page to show the public which business is operating safely. Ms. Engelhart advised that the Health Department opened all environmental services. Ms. Engelhart advised that the Health department remains closed to public except by appointment. Nursing Services are offering reproductive services though telemedicine, contraceptive injection is being offered through drive-thru, and hope to open childhood immunization program by the beginning of June, by appointment. Commissioner Ohler asked what the change of number of cases is

from last week to this week. Ms. Engelhart advised that the number of confirmed cases increased by 2. Commissioner Ohler asked if the 29% of cases who had chronic lung issues had the issues before they contracted the virus. Engelhart advise that is correct they had an underlying chronic lung condition. Commissioner Ohler asked if those who have chronic health conditions and are symptomatic can be tested. Ms. Engelhart advised that is what the Health Department is trying to do. The Health Department are currently testing symptomatic individuals related to the congregate areas. Ms. Engelhart stated the Health Department would like to be able to offer testing to primary health care providers and outpatient facilities. Currently, that is very limited and not available in Carroll County. Ms. Engelhart advised that there is some testing being done in Stark County in Alliance and Canton area as an outpatient service. Ms. Engelhart advised the Health Department is working with LabCorp to offer that type of testing in Carroll County. Commissioner Ohler asked Christopher Modranski, Clerk Supervisor if the Health Department call for volunteers is on the Commissioners' Facebook page and the county webpage. Mr. Modranski stated that he will get that information posted today. Commissioner Ohler advised that this should be sent out to the Leadership Committee as they may have individuals who may be able to help. Mr. Modranski asked if there is a certain number of volunteers that are needed. Ms. Engelhart answered that they do not have a specific number. Ms. Engelhart advised that there is not much of a need for disease detectives right now due to lack of testing, but there is a need for help with the Safety Scouts. There will be an increased need for Disease Detective as the amount of testing increases. Commissioner Wirkner asked if there is a plan for increasing the number of tests. Ms. Engelhart advised that the state plans to increase testing, but it looks like the allocation will be based off the population. Ms. Engelhart stated the Health Department hopes to have a substantial amount of testing available in the county.
