Tom Cottis, Emergency Management Agency Director appeared before the Board to provide an update on the severe weather that came through the county on the evening of Wednesday, June 10, 2020. Mr. Cottis advised that he is working with the National Weather Service (NWS) and has sent some in some pictures for them to review. Mr. Cottis advised that he is waiting to hear back from them regarding a ruling of anything more than high speed winds going through the county during the storm. Mr. Cottis advised that there is a very defined path that starts over on Jade Road, runs diagonal across the county and when his office did the drop points, the path matches up with the tornado activity that was recorded in Columbiana County. Mr. Cottis advised he hopes to hear something in the next few days. Commissioner Wirkner advised that even when a storm is not designated as a tornado or other major event that can be filed for, it helps the NWS with advanced modeling of storms to help predict how storms will react as they move through the county. Mr. Cottis advised that the NWS reviews past storms to help build modeling that will show what they expect storms to do as they move into the county. Mr. Cottis advised that the tornado warnings come out of Oklahoma and there are times that tornados are on the ground before they pick up rotation and by the time the information is picked up and then sent back to Carroll County the storm is already part way through the county. Mr. Cottis advised this is what happened two years ago over by McDonald's. At the time, that storm never showed rotation, and NWS came out and did an assessment. NWS then went back and reviewed video and were able to find the rotation. Mr. Cottis advised that he feels the same thing may happen with the storm from Wednesday evening. Mr. Cottis advised that his office must record all the information that they can and send it to NWS. Commissioner Wirkner advised that he wanted to let residents know that the time and effort Mr. Cottis' office puts in to recording storm information is important for gaining knowledge for the future.
