WHEREAS, H.B. 481 requires subdivisions receiving funds, to pass a resolution affirming that funds from the County Coronavirus Relief Distribution Fund may be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations before receiving said funds; and

WHEREAS, the Carroll County Board of Commissioners is requesting its share of funds from the County Coronavirus Relief Distribution

THEREFORE BE IT RESOLVED by the Carroll County Board of Commissioners that the Board affirms that all funds received from the County Coronavirus Relief Distribution Fund pursuant to H.B. 481 be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations and guidance only to cover expenses that:

IN THE MATTER OF HEALTH DEPARTMENT **COVID-19 UPDATE**



9:09 AM

Kelly Englehart, Director of Nursing appeared before the Board to provide an update on the COVID-19 health crisis. Ms. Englehart advised that there are now 37 confirmed or probable cases in the county. Of those, 27 have recovered and there are still three deaths attributed to COVID-19. Ms. Englehart advised that these numbers are significantly lower than surrounding counties. Ms. Englehart advised that the Health Department has monitored 249 individuals who have been exposed to a confirmed case. Currently, the Health Department is monitoring 26 individuals. They are being quarantined and must report to the Health Department their symptoms and temperatures daily. Ms. Englehart advised that the National Guard will be in Carroll County on Monday, June 22, 2020 to test only the staff at the three long-term care facilities in the county. The National Guard will also be in surrounding counties that day. Ms. Englehart advised that the EMA and Health Department will work together to issue a press release. Ms. Englehart provided an update on testing at Health Department. Ms. Englehart advised that the Health Department has performed four oral swab tests, with none showing positive for COVID-19. The Health Department performed 17 blood antibody tests and only one indicated a past COVID-19 infection. Ms. Englehart advised that testing is done by appointment only and there is a screening process to determine which test, if any, is necessary. Commissioner Wirkner asked if someone is not currently symptomatic, do they take the blood test. Ms. Englehart answered that is the protocol. Ms. Englehart advised that the Health Department working with the school districts in the county. The school districts and Heath Department are waiting for guidelines from the state. The Health Department is working with the superintendents and are doing walk-throughs of the schools to see how schools can safely reopen in the fall. Ms. Englehart advised that the Health Department is working with events over the summer such as tractor pulls and outdoor music events. Ms. Englehart advised that festivals are still not permitted by the state. Ms. Englehart advised that the Health Department has been receiving phone calls concerning residents being told they have been exposed to someone who has tested positive for COVID-19. Ms. Englehart advised that if someone does think they have been exposed to COVID-19, they should call the Health Department. Ms. Englehart advised the only risk of contracting the virus is to be in direct contact with someone who has tested positive. Ms. Englehart advised that they recently heard about a business that closed because there was a rumor of someone who has tested positive and the business did not want to risk their employees' health. Ms. Englehart advised that all Health Department services are operational, though there is new a protocol to follow. Anyone wishing to enter the Health Department are required to be screened before entering and will need to wear a facemask to enter. Masks will be available for those who do not have one, and if someone does not want to wear a mask, the Health Department will try to perform the service curbside. Ms. Englehart advised that all Environmental Health Services and Nursing Services, including both vaccines and reproductive health services are fully operational.

Scott Hillis, Ohio Regional Development Corporation Grant Director appeared before the Board to provide an update on the PY18 CHIP Tenant Based Rental Assistance (TBRA) program. Mr. Hillis advised that he reached out to ADAMHS Board about the TBRA program. Mr. Hillis advised that they did respond by email but did not answer any of Mr. Hillis's questions. Christopher Modranski, Clerk provided an update on the County Coronavirus Relief Distribution Fund. Mr. Modranski advised that the whole county is eligible to receive up to \$900,000.00 from the CARES Act. The county itself is eligible to receive up to \$400,000.00 and the rest is to be split among the townships and municipalities in the county. Mr. Modranski advised that recent changes were made to increase what expenses are eligible to be reimbursed. Mr. Modranski stated that he would like to set up a committee with stakeholders to see the best way to divide the funds. Commissioner Wirkner asked if this is different from the HEROES act. Mr. Modranski advised that it is different. Commissioner Wirkner suggested that committee be made of the Board President, someone from the Auditor's Office, a representative from the largest township, a representative from the largest municipality, someone from Jobs and Family Services, and the Economic Director. Commissioner Ohler asked about a breakdown of what the county will receive from the CARES Act. Mr. Modranski advised that there is a formula that divides the townships' and municipalities' shares of the funds. Commissioner Ohler stated that since there is a separate fund for townships and municipalities, there is no need to include them on the committee. Commissioner Wirkner stated that since this is a reimbursement fund, he does not see that the townships would have many eligible expenses for this fund and those unused funds could go back to the county. Mr. Modranski advised that he would like the committee to decide what to do if these funds come back to the county instead of one person. Commissioner Wirkner asked if there is a grant opportunity for local businesses. Mr. Modranski advised that Tuscarawas County did set up a grant for businesses. Mr. Modranski advised that there is a formula that needs to be followed for distribution to the townships, but there is more flexibility for the funds coming to the county. Commissioner Ohler asked if the Health Department should be included in this committee. Mr. Modranski advised that most expenses will likely be attributed to the Health Department so the committee should include either someone from the Health Department or EMA. Commissioner Mickley asked if the Board should have a representative on committee. Commissioner Wirkner advised that the committee would still have to report to the Board, so the Board will still have input.
