#### IN THE MATTER OF HEALTH DEPARTMENT – COVID-19 UPDATE

Kelly Engelhart, Director of Nursing appeared before the Board to provide an update on the COVID-19 health crisis. Ms. Engelhart advised that there are 44 confirmed or probable cases of COVID-19 in the county. Of those, 34 have recovered and 3 deaths are attributed to the COVID-19 virus. Ms. Engelhart advised that the increase in probable cases is because of positive blood antibody tests. Ms. Engelhart advised that Carroll County is in the lower 25 percent of cases in the state, while Tuscarawas County is in the upper 25 percent. There have been two exposures in congregate facilities and the Health Department is working on contact tracing. There are 75 residents being monitored. There is a total of 310 residents being monitored. If any of those residents became symptomatic, they were tested. As of today, none of those tests came back positive. Ms. Engelhart advised that Ohio will be moving to a risk advisory system. There will be different levels of risk based on community transmission rates in each community. There will be three levels of risk: low, moderate, and high. These levels will determine what safe operations will need to happen in their communities. Ms. Engelhart suspects that the current order that will expire at end of June will not renew on July 1st. After the current order expires, the risk advisory system will be used to give communities guidance instead of the state issuing orders. Ms. Engelhart advised that the risk advisory system will be similar to the severe weather advisory system. The Health Department will provide more information to community leaders when its available. Ms. Engelhart advised that the state is working on recommendations for schools but would like decisions to be locally driven by the local health department and school districts. Ms. Engelhart advised that these decisions will be based on available data and the local risk levels. Amy Campbell, Office Administrator is currently working with the Education Service Center. Ms. Engelhart advised that the Health Department is working with camps in the county and how they can safely operate. Ms. Engelhart advised that there are 11 residential camps in the county. Some of those are operating as family style where families are able to stay the night but only in pods of families, while others are operating as day camps. Ms. Engelhart advised fireworks are permitted over the 4<sup>th</sup> of July, but large gatherings are discouraged. Ms. Engelhart advised that festivals are still not allowed throughout the summer. The Health Department is working with individuals who would like to hold events such as tractor pulls. Commissioner Wirkner asked if, after July 1st, the COVID-19 response will be community driven and will be governed by the community not the state. Ms. Engelhart advised that it seems that is the direction the state is moving. Ms. Engelhart advised that there will not be an update next Thursday due to the 4<sup>th</sup> of July holiday. Commissioner Wirkner asked if it does become a community-based decision, will the Heath Department contact the Board. Ms. Engelhart advised that they will provide that information as soon as they receive it.
