HEALTH DEPARTMENT – COVID-19 UPDATE



9:09 AM

Kelly Engelhart, Director of Nursing appeared before the Board to provide an update on the COVID-19 health crisis. Ms. Engelhart advised that there are 33 confirmed or probable cases which is up three cases from last week. Ms. Engelhard advised that there have been four confirmed cases in the Amish community and are not isolated to one Amish community. There are cases in the communities in Perry Township, Loudon Township, and Augusta Township. The Health Department has been working with a liaison from Holmes county who has been assisting with the compliance of monitoring cases in the Amish communities. Ms. Engelhart advised that the Health Department has been monitoring 103 individuals who have been possibly exposed to COVID-19. Around 80 of those will no longer be monitored after today. Ms. Engelhart advise that these are related to a possible exposure in a long-term care facility. Ms. Engelhart advised that the Health Department has been meeting with the local school superintendents and athletic directors to discuss starting the training for athletes. Ms. Engelhard advised that all three school districts are starting training this week and have set up protocols to safely provide training for athletes over the summer. Ms. Engelhart advised that Wendy Gotschall, Health Commissioner and Tom Cottis, EMA Director attended the Fair Board meeting to provide the Fair Board with guidance. The Fair Board decided to cancel the fair this year. Ms. Engelhart advised that the Health department now has the capability to test and will start next week. Ms. Engelhart advised that there will be two forms of tests. One will be the oral swab which will be used for diagnostic purposes for those who are showing symptoms. The tests will be provided to those with a doctor's order or the medical directors can provide an order for an individual after they are screened. This testing will be provided on Tuesday and Thursday mornings. The second test will be serum-blood pathogen testing with LabCorp and will be on Wednesdays by appointment only. This test is for individuals who think they may have had the infection but was before testing was available. Ms. Engelhart advised that this testing will provide information on the prevalence of the virus in the county. Ms. Engelhart advised that there will be a soft roll out next week. Ms. Engelhart advised that the Health Department does not have a large quantity of the nasal swab tests. The Health Department will be issuing a press release on Monday. Ms. Engelhart advised that there is an order by governor for testing of all long-term care facilities. All residents and staff will be tested. This testing will be done by the National Guard. Ms. Engelhart advised that the focus is currently on any hot spots. The Health Department and EMA will work with the National Guard when they come to the county for testing. Ms. Engelhart advised the state is targeting long-term care facilities because that is where the largest number cases are. Ms. Engelhart advised that there will be a prevalence testing research study conducted by the Ohio State University Wexner Medical Center and Research Department in conjunction with the Ohio Department

of Health. Ms. Engelhart advised that residents may receive a postcard asking to be part of the study. Ms. Engelhart advised that this study is being done across the state and is done on a voluntary basis. If someone wants to participate, a team of nurses and investigators will come into an individual's home and will be tested by a nasal swab test to determine if they currently are infected and by a blood pathogen anti-body test to determine any past infections. Ms. Engelhart advised that this study will determine the prevalence of COVID-19 across the state. Ms. Engelhart advised that they are looking for around 1,200 participants. Commissioner Wirkner asked if there will be any charge to the public for the tests. Ms. Engelhart advised that billing will be charged to insurance company and if someone does not have insurance, the Health Department plans to use a COVID-19 grant to pay for testing. Ms. Engelhart advised the hope is to not have a direct charge to an individual for COVID-19 testing.
