Brian Mosier of Clark, Schaeffer and Hackett appeared before the Board to present results from the 2019 Audit. A copy of the audit results is on file at the Commissioners' Office. Mr. Mosier advised that the county received a clean audit and there are no notes of non-compliance. Mr. Mosier advised that this year the audit focused on the Temporary Assistance for Needy Families (TANF) program and found no issues with the administration of the TANF program. Mr. Mosier advised that his firm was on site occasionally but did most of the audit remotely and everyone in the Auditor's Office cooperated to get audit completed. Mr. Mosier provided information on the Auditor of State Star Rating System. The Star Rating System monitors the transparency in government and ranges from 1 star to 4 stars. The county has implemented 5 of the 7 best practices which means the county has earned the maximum 4 stars rating. Commissioner Wirkner stated that he appreciates the information presented and the slides that accompanied the presentation. Commissioner Ohler offered congratulations to the Auditor's Office for their hard work. Commissioner Ohler asked about the non-compliant line on the last page.
