Christopher R. Modranski, Clerk advised that the Coronavirus Relief Funds Committee has approved \$150,000.00 for a small business COVID-19 relief grant program which will be called the Carroll County Cares COVID-19 Small Business Grant program. Mr. Modranski advised that the criteria for the grant are as follows: 1. Businesses must demonstrate a negative impact from state mandated closures and/or restrictions; 2. Revenue must have declined by 10% due to COVID-19 as of March 15, 2020; 3. Businesses must be located in Carroll County; 4. Businesses must have been in business prior to February 15, 2020; 5. Businesses must have two or more but fewer than 25 full-time equivalent employees as of March 15, 2020; 6. Businesses must have annual gross receipts of \$2,000,000.00 or less. Mr. Modranski advised that private businesses will be eligible for grants up to \$10,000.00 and he is plannning to have the application available on the county website on August 26, 2020 at 12:00 p.m. Mr. Modranski advised that the deadline will be September 2, 2020 and that deadline will be extended if needed. Mr. Modranski advised that the applications will be reviewed by the Coronavirus Relief Funds Committee and will be judged on a point system. Mr. Modranski hopes to distribute the grant money in the middle of September. Commissioner Wirkner asked how Mr. Modranski plans to spread the word about the grant. Mr. Modranski advised that he will be doing a social media blitz, advertising in the local newspapers and he has also procured the list of all active vendors in Carroll County to send a postcard via USPS. Mr. Modranski advised that there are still some details that need finalized, including a grant agreement and a status report to show how the business used the money, that will be turned in to Economic Development. Mr. Modranski advised that he is working with Ashtabula County so that they are not recreating the wheel in regards to the grant documents. Commissioner Wirkner advised that the Economic Development has been quite active assisting businesses this year. Mr. Modranski advised that he has approximately five active projects going on right now.
