Commissioner Wirkner advised that there is a clearer picture of the 2021 Budget and asked Commissioner Ohler to provide an update on the budget. Commissioner Ohler advised that he has been working closely with the Auditor's Office. Commissioner Ohler advised that there is a reduction of anticipated receipts and he does not see any increase in receipts because most of the revenue has been collected and accounted for in the budget such as property taxes. Commissioner Ohler advised that he anticipates an additional \$930,000.00 in sales tax revenue for the rest of this year. Commissioner Ohler estimates that there will be a shortfall in the 2021 Budget in amount of \$900,000.00. This will depend on what percentage of 2020 receipts that the Auditor's Office will certify. Commissioner Ohler advised that the Auditor has always been conservative on what they will certify. Commissioner Ohler advised that revenue received that exceeds that certification will go towards the carry-over for the next year's budget. Commissioner Ohler advised that the \$900,000.00 shortfall estimate is based on a 90% certification from the Auditor's Office. Commissioner Ohler advised that if there is an 80% or 85% certification the shortfall will increase. Commissioner Ohler advised that there will be a shortfall for next year's budget that will result in a \$1 million reduction in next year's requests. Commissioner Wirkner advised that there is an estimated \$300,000.00 in unappropriated funds, which compared to a \$9.5 million budget is very modest. Commissioner Wirkner asked if that is enough to carry the county through. Commissioner Ohler advised that in a normal year, that amount should be enough. Commissioner Ohler advised that it will depend on what the receipts for 2021 look like. Commissioner Ohler advised that when he first came on as a Commissioner, the county had no unappropriated funds that could be used for emergencies. Commissioner Ohler advised that he feels confident the county can move forward without a shortfall in the 2021 Budget.
