Commissioner Wirkner asked Mr. Cottis who owns the repeaters for the current, Ultra High Frequency (UHF), system. Mr. Cottis advised that the repeaters are currently in the EMA inventory. Mr. Cottis advised that EMA acquired the repeaters through two grants. Commissioner Wirkner asked if EMA can continue maintain the repeaters. Mr. Cottis advised that EMA cannot as there is not enough funds in their budget. Mr. Cottis advised that the ownership of the UHF repeaters should transfer over to 9-1-1 or to the Board of Commissioners. Commissioner Wirkner advised this was brought up at a recent Firefighter Chiefs Association meeting, and no one wanted to take ownership of the equipment. Commissioner Wirkner advised that the Board of Commissioners had to cover costs for damage to the UHF receiver in Sherrodsville. Commissioner Wirkner advised that there was a maintenance agreement, but the Board had to terminate the agreement due to a budget crunch. Commissioner Wirkner advised that the receivers were operating without a maintenance agreement which means the Board had to pay for any repairs. Commissioner Wirkner advised that it was discussed before to switch to MARCS, but there was push back from some of fire departments. Commissioner Wirkner advised that in order to save money the repeaters have been repaired with parts ordered from

eBay and older equipment. Commissioner Wirkner recommended that the local fire departments should embrace a grant for the MARCS radio system, and the Board should send a letter of support. Commissioner Wirkner advised that the county will still need to maintain UHF system for paging services until the county is able to purchase the pagers that is used in MARCS. Commissioner Wirkner advised that all firefighters are volunteers and should not be responsible to purchase the MARCS paging equipment. Commissioner Wirkner advised that 9-1-1 funds cannot be used for administrative dispatch. Commissioner Wirkner recommended to show support for the county fire departments to seek a grant to help with the transition to MARCS. Mr. Cottis agreed. Mr. Cottis advised that they considered a grant opportunity back in 2012, but they did not have all of the fire departments support. Mr. Cottis advised that EMA supports the county fire departments switching to MARCS as all surrounding counties have already switched to MARCS. Mr. Cottis advised that ownership of UHF repeaters should be transferred to 9-1-1.

Ms. Engelhart advised that the Health Department does not know how many vaccines they will receive, so they need to be ready for any amount. Ms. Engelhart advised that the drive-through flu clinic will start on Friday, October 2, 2020. Vaccines will be available Friday in the morning from 7:00 a.m. to 1:00 p.m. Flu Vaccines will also be available next Friday in the afternoon from 11:00 a.m. to 5:00 p.m. The Health Department is asking for anyone interested in getting a flu vaccine to call ahead to pre-register which will help the Health Department to prepare.
