

Commissioner Wirkner advised that he and Commissioner Ohler attended the Security Committee meeting at 10:00 a.m. Commissioner Wirkner advised that the Board received a letter from the Carroll County General Health District (CCGHD) dated November 25, 2020 indicating that there are numerous confirmed cases of COVID-19 in the courthouse and one of the recommendations is that visitors to the courthouse be limited. Commissioner Wirkner advised that the judges have given a verbal order to reduce courthouse hours and that order will become effective Monday, December 7, 2020. Commissioner Wirkner advised that the reduced hours are as follows: Monday through Friday 8:00 a.m. – 9:00 a.m. for the at-risk population; Monday and Thursday 9:00 a.m. - 3:00 p.m. for the general population; Tuesday, Wednesday, and Friday 9:00 a.m. - 1:00 p.m. for the general population and Tuesday, Wednesday, and Friday 1:00 p.m. – 3:00 p.m. by appointment only for general population. Commissioner Wirkner advised this order will be put into writing and anticipates that the Board will approve a resolution on Thursday, December 3, 2020 as a follow-up to those written orders. Commissioner Wirkner advised that there was discussion about additional precautions to be taken at the security station. The CCGHD has advised that only about 30% of people have a high temperature with the virus. Commissioner Wirkner advised that a sign will be placed at the security station that indicates the various symptoms that could be experienced with the onset of COVID-19. If a visitor answers yes to any of the symptoms, or the symptoms are observed by the deputy at the security station, they will be turned away. Commissioner Wirkner advised that a COVID Defense Task Force meeting will be held as soon as they have enough information gathered. Commissioner Wirkner advised that the CCGHD has advised that hospital bedspace in northeast Ohio is essentially full. Commissioner Wirkner advised that residents need to have a sense of urgency to safeguard their health and do everything possible to stay healthy.
