**BIDDING NOTICE
ASPHALT MATERIALS & ROAD OIL**

Sealed bids will be received by the Board of Commissioners of Carroll County, Ohio, at the office of the Carroll County Engineer located at 200 Kensington Road NE, Carrollton, Ohio, up to and opened at 9:00 a.m. on Thursday, March 18, 2021 for asphalt materials and road oil to be used by the County Highway Department or any of the 14 townships which comprise Carroll County for the period of April 23, 2021 through April 22, 2022.

Liquid material bids shall be the price per gallon F.O.B. at the stated source for quantities less than 1,500 gallons and/or transport loads delivered and unloaded at a location in Carroll County specified by the County Engineer. The bidder must submit proof of certification with the State of Ohio Department of Transportation for the material bid at the time of the bid opening.

Plant mixed asphalt material bids shall be the price per ton F.O.B. at the source and/or delivered and unloaded at a location in Carroll County specified by the County Engineer.

The Board of Commissioners reserves the right to accept and/or reject any or all bids and to determine the lowest and best bid. Length of haul, temperature correction and availability of material will be considered when determining the lowest and best bid.

Bids shall be sealed and plainly marked "ASPHALT MATERIALS AND ROAD OIL".

A representative of the company should be present at the bid opening.

NOTE TO BIDDERS: FUEL SURCHARGES WILL NOT BE ACCEPTED; BID ACCORDINGLY.

**BID SPECIFICATIONS FOR
LIQUID BITUMINOUS MATERIALS**

Bids are requested for grades of Liquid Asphalt listed on the attached sheet titled "Liquid Asphalt and Road Oil". Bids will not be considered which do not address each and every specification and requirement listed herein.

Bid price per gallon f.o.b. supplier's plant, and the price per gallon delivered to the supplier's portable tank to any location within Carroll County as designated by the Carroll County Engineer. The various grades of bituminous materials shall meet or exceed the pertinent State of Ohio, Department of Transportation Materials Specifications. The bidder must submit proof of certification with the State of Ohio Department of Transportation.

Suppliers shall understand that no guarantee is given to the actual quantities needed, but the successful bidder shall be required to furnish all of the Carroll County Engineer's requirements as ordered from March to November. The estimated quantity of material required is approximately 50,000 gallons.

The intent is to obtain the most satisfactory performance from the products available. Bidders shall furnish with their bid documents showing that their company has manufactured these products to the stated specifications and successfully supplied all items bid. Bidders shall also furnish with their bid, documents showing lab analysis of aggregate gradation and necessary sealing rate application for both asphalt and aggregates. These lab analyses shall be for actual samples taken at specified locations by the Carroll County Engineer's office. Any bid not including this information shall be rejected.

AGGREGATES: The bidder shall obtain samples of said proposed aggregates and shall confirm that the aggregates and liquid asphalt bid are compatible in all respects. Bidders shall attach all specifications of asphalt products. Any bid not including this information shall be rejected.

DATA SHEETS: In order that the County can ascertain that the materials being bid meet the minimum specifications, the bidder shall submit laboratory test results which show results of all tests required in accordance with the Ohio Department of Transportation Materials Specifications. This data shall include the name and address of the laboratory performing said tests. Any bid not including this information shall be rejected.

PRODUCT USERS: Bidders shall attach to their bid a list of users of the products being bid. Such list shall be of agencies that use the products in a manner similar to that being proposed by the Carroll County Engineer. The list shall contain the name, title, and phone number of a person with knowledge of such materials usage. Such reference may be referred to by the Carroll County Engineer prior to the award of the bid. Any bid not including this information shall be rejected.

MATERIALS SAMPLE: Prior to the award of any bid, the County may require the submittal by the bidder of a one-gallon sample of the asphalt products being considered for use. Such sample will be submitted by the County to a laboratory for testing to confirm that the material sample is in accordance with the specifications and to the previously submitted laboratory test data.

FIELD PERFORMANCE: All of the laboratory and test data available is of little use if the asphalt products supplied will not perform the intended functions in the field. Performance in use is the primary concern of the Carroll County Engineer. Therefore, the field performance if not satisfactory to the Carroll County Engineer will be reason for discontinuing use of the product and rejecting the bid from that supplier and switching to a bid previously not awarded. The County does realize that variations in road surfaces, moisture content in stockpiles, and atmospheric conditions can have an effect on the performance of a product. However, should any concern develop with the field performance, the bidder shall provide immediate technical assistance to resolve such problems. Any sampling, testing, or laboratory work associated with the resolution of any field performance problem shall be the financial responsibility of the supplier.

DELIVERY: Delivery of all materials shall be of the type, kind, quantities, and times as the County Engineer or his authorized assistant may so order. Deliveries will be in transport quantities. Ordering will occur up to 12 hours before delivery is expected. The successful bidder will furnish a 10,000-gallon portable storage tank meeting Federal Motor Carriers Safety Regulations 393.9, 393.11, 393.42 and 393.75 at no additional expense to the County. No demurrage will be charged.
