Commissioner Wirkner opened the public hearing. Those present were Trina Woodland, Community Development Specialist, Jeannette Wierzbicki, OMEGA Executive Director, Vince Lehman, Johnson Controls Solutions Development Manager, Luke Kopyar, Johnson Controls Account Executive, Dawn Faulk, Carroll Golden Age Retreat Superintendent, Melissa N. Schaar, Clerk, Ronald M. Nuzzolillo Jr, Assistant Clerk I, Commissioner Robert E. Wirkner, Commissioner Jeffrey L. Ohler, and Commissioner Christopher R. Modranski. Ms. Woodland advised that the Community Development Block Grant (CDBG) program is authorized under Title I of the Housing and Community Development Act of 1974 and is administered by the U.S. Department of Housing and Urban Development (HUD). The Office of Community Development, a division of the Ohio Development Services Agency, administers the CDBG program for the state of Ohio. HUD regulations require that, if a community is applying for CDBG funds, two public hearings must be held: the first to discuss the CDBG program in general and the second to discuss the specific funding program for which the application is being prepared. Ms. Woodland advised that this is the first public hearing. Ms. Woodland advised that the three objectives of the CDBG program are: Benefit persons of low to moderate income (at least 51% LMI); Prevent or eliminate slum and blight; & Meet an urgent community development need (serious and immediate threat to the health and welfare of the community). The Carroll County Golden Age Retreat qualifies under the low to moderate income objective component: Limited Clientele. Ms. Woodland provided the goals of the CDBG programs which include: create and/or retain jobs for persons of low to moderate income; improve housing and neighborhoods for persons of low to moderate income; upgrade and provide infrastructure for persons of low to moderate income; resolve serious and immediate threats to the health and welfare of the community; revitalize downtowns; implement fair housing programs; & special funding through the Coronavirus Aid Relief and Economic Security Act (CARES Act) to fund public services and public facilities projects to prevent, prepare for, and respond to the COVID-19 pandemic. Ms. Woodland advised that Affordable Housing programs include Community Housing Impact and Preservation Program, Housing Development Assistance Program, and CHDO Competitive Operating Grant Program. Homeless and Supportive Housing programs include Homeless Crisis Response Program and Housing Opportunities for Persons with AIDS. Community and Economic Development programs include Community Development Program and Economic Development Loan and Public Infrastructure Grant Program. Targets of Opportunity Grant programs include Economic and Community Development, Downtown Revitalization Grant, New Horizons Fair Housing Assistance Program, Ohio Housing Trust Fund Special Projects Grant Program Emergency Shelter Program Grants. Ms. Woodland provided information about the Target of Opportunity CARES Act CDBG-CV Program. The State of Ohio received \$27.2 million in the first allocation of Community Development Block Grant (CDBG-CV) funds through the Coronavirus Aid Relief and Economic Security Act (CARES Act) to be administered by the Ohio Development Services Agency's Office of Community Development (OCD). OCD will use these funds for public services and public facilities projects to prevent, prepare for, and respond to the COVID-19 pandemic. There will be two more rounds of allocations for 37.4 million and 18.3 million respectively. Guidelines for future rounds have not been set. There is no grant ceiling for the maximum grant amount. The deadline will not be known until the

first allocation is expended. There is no leverage required. The proposed project cost is \$991,228.00. The administrative cost will be \$20,000.00. The total project cost is \$1,011,228.00. Ms. Woodland advised that her email address can be posted on Facebook. Any comments will be responded to in writing within 15 days of receipt. Copies of comments and responses will be on file at the Carroll County Commissioners Office and at the Ohio Mid-Eastern Governments Association (OMEGA). Ms. Woodland advised that the next public hearing is scheduled for March 22nd at the same time.

LEGISLATIVE UPDATE – INDIGENT DEFENSE FUND



Commissioner Modranski advised the County Commissioners Association of Ohio (CCAO) has requested county commissioners to reach out to their legislators to support and co-sponsor Budget Amendment HC0449 for the Indigent Defense Reimbursement Program. Commissioner Modranski advised that this amendment would appropriate an additional \$8.3 million in FY2022 and an additional \$12.3 in FY2023 which would fully fund the Indigent Defense Reimbursement Program. Commissioner Modranski advised that Governor Mike DeWine submitted his budget proposal which included 96% and 94% reimbursement. This amendment would bump that up to 100% reimbursement.
