Commissioner Wirkner advised that each year the Emergency Services Appreciation ceremony is held, and the ceremony also includes a time to recognize civilians. Commissioner Wirkner advised that the selection committee is compromised of a representative from each discipline: fire services, EMS, police, sheriff, plus there is a member from the Commissioners' office. Commissioner Wirkner advised that nominees for the award are forwarded to the Commissioners' office and a meeting of the selection committee is held on or around March 1 of each year. The following criteria are used during the selection process: 1. Candidates are presented by letter designation instead of their name; 2. If a committee member has a candidate up for nomination or a conflict with a nominee, the member shall abstain from the vote; 3. Votes are done by ballot with a vote of yes, no or abstain; The secretary will count the votes; 4. A tie vote is a no vote; 5. Nominations will no longer be made based on Narcan administration only; there needs to be special circumstances in addition to the Narcan administration such as CPR or other life-saving measures. Commissioner Wirkner advised that the committee reviews each case and only after the vote does the committee know the names of the nominees. Commissioner Wirkner advised that this year there was a citizen who assisted the emergency services with the performance of their duties. Commissioner Wirkner advised that Gary Shepherd was present for the events that occurred in the early morning of March 18, 2020 when a fire broke out in a home on North High Street in Carrollton. Mr. Shepherd assisted the police officers in rousing and evacuating the occupants of the home. Commissioner Wirkner read the Proclamation.

Captain Cheryl Keyser, 9-1-1 Coordinator appeared before the Board to discuss the addressing issues from a 9-1-1 perspective. Commissioner Wirkner advised that steps have been taken to correct as many of the addressing issues as possible and asked Captain Keyser to share how the address corrections are progressing. Captain Keyser advised that before the county transitioned to NextGen 9-1-1, the Commissioners funded an electronic map project. Captain Keyser advised that when they worked on the corrections to the map, they discovered that different roadways have house number issues. For example, there could be an area that the number should be around 10000, but is 4000. Things have changed and are more organized now but it can throw people in a panic to have to change their address, especially with mortgages, etc. Captain Keyser advised that there was a way to work around that and that was to geolocate the GIS locations. The wrong addresses would pop up as an error and her staff had to go through one by one and suppress the error after confirming that 4000 address does belong in the 10000 road numbering. Tom Konst, Regional Planning Commissioner Director has come on board and is doing a fabulous job. Captain Keyser advised that the electronic map that runs the 9-1-1 is in the County's system, but if a resident is searching for an address, they will type that into their mobile device, which is a Google map. The county 9-1-1 system is not using Google maps. Captain Keyser advised that there are emergency services that are using Google maps to get location information for emergencies that they are sent to, which leaves the possibility of Google maps populating no where near where the emergency is. Captain Keyser advised that Mr. Konst is working with 9-1-1 and the Auditor's office to work on the areas that still have problems and is writing letters and talking to the residents. Captain Keyser advised that the 9-1-1 maps are not the problem, the problem is that not everyone uses it. Captain Keyser advised that they do find an error from time to time and they correct it. Commissioner Wirkner advised that residents need to be aware that fire and emergency services can find their location even if their address is incorrect. Commissioner Wirkner advised that this is possible because of the map overlays that automatically recalibrate and adjust to allow for errors in the addressing. Commissioner Wirkner asked residents to cooperate with the RPC personnel as they attempt to mitigate the addressing errors that are found. Captain Keyser advised that she is extremely happy with the cooperation between the offices to correct the errors. Commissioner Wirkner advised that prior to NextGen9-1-1, the Commissioners attempted to have an outside company handle the corrections to the overlays. It was too cumbersome and too reliant on someone outside of the county, so the Commissioners chose, with the cooperation of the Sheriff's office, to fund the software and train inside personnel to make the overlays and corrections in-house.

IN THE MATTER OF COVID-19

HEALTH DEPARTMENT UPDATE

ڬ 9:20 AM

Kelly Engelhart, Director of Nursing and Population Health appeared before the Board to provide the weekly COVID-19 update. Ms. Engelhart advised that as of yesterday, the total number of cases for Carroll County is 1,968. Of those, 1,895 cases are recovered, there are 40 deaths recorded, 63 active cases and three outbreaks. Ms. Engelhart advised that Ohio Department of Health (ODH) has changed how they are documenting deaths. They are now using vital statistics from the death registry, instead of the reporting system. Ms. Engelhart advised that if Carroll County residents die at a hospital outside of Carroll County, the Health Department is not always notified by the hospital, but the death is counted because it is counted by residence. This is why the death count went from 37 to 40. Ms. Engelhart advised that there were 545 cases in January, which were expected due to the holidays in December; 155 cases in February and 37 cases so far for March. Along with the reduction in cases, the hospitalization rate is going down. Ms. Engelhart advised that in December, January and February the hospitalization rate was approximately 6%, and for March it is at 2.7%. Ms. Engelhart advised that testing continues at the Health Department Monday through Friday from 8:00 a.m. to 12:00 p.m. The Health Department currently has a 37% positivity rate. Ms. Engelhart advised that her office is offering the rapid tests which give results in 15 minutes. Ms. Engelhart advised that the Health Department has received 4,800 vaccines to date and has administered 4,669 of those doses. Vaccination clinics are being held at the Carroll County Transit facility and at the Damascus Friends Church campus in Malvern. The clinics are being transitioned to paperless registration through ArmorVax. However, if any resident needs assistance registering, they can call the Health Department at 330.627.8928. Ms. Engelhart advised that the Senior Citizens Friendship Center and Jobs and Family Services will also assist residents with registering. Ms. Engelhart advised that the ODH numbers from the state are about two days behind. Carroll County currently has approximately 20.22% of the eligible population vaccinated. 55%-60% of seniors ages 65+ are vaccinated, the majority of which are the 65-69 age group. Ms. Engelhart advised that this is the county's largest population. Ms. Engelhart advised that the remainder of the 5,441 doses that have been administered in Carroll County have been administered by Discount Drug Mart Carrollton and Minerva locations. Ms. Engelhart advised that the DDM locations have vaccine available and residents can call and schedule an appoint at DDM as well. The State of Ohio is currently at 21% of the eligible population vaccinated, so Carroll County is on track. Ms. Engelhart advised that Governor DeWine has added the 40+ population and four additional medical conditions effective Friday, March 19, 2021. Ms. Engelhart advised that her office will be finishing the school employees' second vaccinations this week. There are two clinics scheduled next week, primarily for second doses, and both clinics are full. Ms. Engelhart advised that she anticipates continuing the Tuesday and Thursday vaccine


clinics as long as the Health Department receives enough vaccine. Ms. Engelhart advised that Governor DeWine will open the vaccines up to 16+ on March 29, 2021. The Health Department typically receives the Moderna vaccine which is approved for people 18+. MS. Engelhart advised that the Pfizer vaccine is approved for people 16+. Ms. Engelhart advised that her office utilizes the wireless emergency notification system (WENS) to notify residents of available appointments and changes to clinics. Ms. Engelhart advised that her office really appreciates the WENS service. Commissioner Wirkner advised that he had seen on the news that 25 states have had an increase of their COVID-19 cases and Ohio had been dropping but is now plateauing. Ms. Engelhart advised that she suspects that this is due to the variant strains of COVID and she expects to see the variant strains as the dominant strains in Ohio by the end of March or beginning of April. Ms. Engelhart advised that she believes this is why the Governor has opened up the vaccine to everyone, because the more people who are vaccinated reduces the amount of transmission. Commissioner Modranski asked how many doses her office is receiving weekly. Ms. Engelhart advised that she is expecting 300 doses next week which is lower than she would like to see. She is advocating to get more doses for the county. Ms. Engelhart advised that there are 2,900 providers in the state of Ohio. Carroll County only has three pharmacies, no hospital and a limited number of physicians. Other counties have multiple providers to help take the burden off of the Health Department and the lack of providers puts our county in a bind as far as receiving more doses of vaccine.

IN THE MATTER OF VILLAGE OF BOWERSTON WATER SERVICE

Bob Allen, Infrastructure Business Manager for E.L. Robinson Engineering, Jack Ramsey, Project Manager for E.L. Robinson Engineering and Allen Case, Bowerston Village Administrator appeared before the Board to discuss the waterline project for the Village of Bowerston. Mr. Allen provided a handout to the Board that provides a summary of the existing system. Mr. Allen advised that a portion of the project includes extending water service to an unserved area in New Hagerstown, which is in Carroll County. Mr. Case advised that about 1.75 miles from the current water system there are approximately 25 homes/43 residents in the area with well water, and they would like to extend the water service to that area. Mr. Case advised that he has spoken to homeowners in the area and they are supportive of the water project. Commissioner Wirkner advised that he sees there is a proposed Conotton Extension as well. Mr. Case advised that they have already spoken to the Harrison County Commissioners, and the residents in that area are supportive of the project as well. Mr. Case advised that the purpose of their visit today is to get the blessing of the Board for the project. Commissioner Ohler advised that he thinks it is a great idea. Commissioner Modranski asked what the cost to the residents will be. Mr. Case advised right now, there will be no charge for the connection fee as it will be part of the construction cost. Mr. Case advised that they are aiming for a monthly bill of \$60.00-\$75.00 per month, which will actually save some residents money because of currently needing water purification or water softening systems. Mr. Allen advised that, with the understanding that they have not received any permissions yet, they have applied for some Ohio Environmental Protection Agency (EPA) Water Supply Revolving Loan Account (WSRLA) principal forgiveness funds in hopes of getting funds later this year, with the understanding that if the Board is against the project, then the New Hagerstown extension will be out of the project. Mr. Allen advised that they have a meeting scheduled with Ohio Mid-Eastern Governments Association (OMEGA) staff on March 29, 2021 to discuss other funding options. Commissioner Modranski asked if the residents will be required to tap in to the waterline. Mr. Case advised that residents are not required to hook in. However, they will ask for a commitment from each affected resident before they get too far along with the project. Commissioner Wirkner asked if Mr. Allen and Mr. Case would like a motion allowing them to move forward with their due diligence for the project, with the understanding that they will report back for a final answer.

Ronald Nuzzolillo Jr, Assistant Clerk advised that with the warm weather coming, many residents are starting outside projects that may require digging. Mr. Nuzzolillo advised that Ohio law requires property owners and contractors to call 8-1-1 -- to have underground utility lines marked -- at least two business days prior to ANY digging project. Ohio811, formerly known as the Ohio Utilities Protection Service, operates the state's one-call system. A vital resource for Ohio residents and businesses alike, Ohio811 acts as a communications link between utilities and individuals and companies planning any digging activity. Under Ohio law, individuals and excavators MUST contact Ohio811, by calling 8-1-1, at least two business days, but no more than 10 working days (excluding weekends and legal holidays) before beginning ANY digging project. This service is free of charge. Professional locators are then sent to the requested digging site to mark the approximate locations of underground lines and facilities with flags, spray paint or both. State law requires a call to 8-1-1 for every digging project, no matter how big or small. Installing a mailbox, putting in a fence, building a deck, or planting a tree, are all examples of digging projects that require a call to 8-1-1 before starting.
