## **RESOLUTION #2021-19** A RESOLUTION MODIFYING OPERATIONS THE CARROLL COUNTY COURTHOUSE

WHEREAS, on December 3, 2020, the Board of Commissioners of Carroll County adopted Resolution 2020-41 limiting public access

WHEREAS, on March 23, 2021 the Courthouse Security Committee met and decided, with the guidance of the Carroll County General Health District, that the Courthouse could resume normal hours; and

WHEREAS, on March 25, 2021, the Carroll County Court of Common Pleas, the Carroll County Municipal Court, and the Probate and Juvenile Division Court of Common Pleas, issued an order Modifying Courthouse Operations;

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners, Carroll County, Ohio:

Section 1: The Courthouse will resume normal business hours of Monday through Friday from 8:00 a.m. to 4:00 p.m.

Section 2: All visitors entering the Courthouse are required to wear facial coverings and said facial coverings shall be worn while conducting business in the courthouse. Facial coverings must be worn properly so that the mask covers the mouth and nose.

Section 3: If the visitor presents without a facial covering, the county will provide them one.

Section 4: If the visitor refuses to wear the facial covering, the visitor will be asked to leave the facility.

Section 5: All courthouse employees must wear facial coverings anytime they are outside of their own individual office.

Section 6: All individuals entering the Courthouse shall be subject to a non-invasive scan for elevated body temperature. Any individual, including employees, with an elevated temperature shall be denied access to the Courthouse.

Section 7: A list of COVID-19 symptoms will be provided by the Carroll County General Health District and shall be posted at the entrance. All who enter will be checked for the same. All who enter will be required to verify they are symptom free. Visitors may be denied access if any symptoms exist.

Section 8: Access shall be temporarily refused by security staff to any visibly-ill person.

Section 9: All individuals must maintain the six (6) foot social distancing as set by the Center for Disease Control and Carroll County General Health District

Section 10: This order will be effective Thursday, April 1, 2021 until the end the COVID-19 pandemic or ordered by this Board.
