Commissioner Wirkner advised that he voted on directors as the County's Voting Representative. Commissioner Wirkner advised that one thing learned during the meeting was that reimbursement rate for indigent defense is projected to be 94% to 96%. Commissioner Wirkner advised that, in the past, the reimbursement rate was only 20%. Commissioner Wirkner advised that another thing learned was guidance on the recent stimulus bill will not be released until mid-May. Commissioner Wirkner advised that the county may receive the funds before the guidance.

COMMUNITY HOUSING IMPACT AND PRESERVATION (CHIP) PUBLIC HEARING #1



Susan Moore, Community Development Specialist opened the first public hearing for PY21 Community Housing Impact & Preservation (CHIP) Program at 9:30 a.m. Ms. Moore advised that Carroll County is eligible to apply for up to \$400,000.00. Ms. Moore advised that Owner Rehabilitation is capped at \$64,400.00. Rentals are eligible for assistance, but the landlord must contribute 50%. Owner Rehabilitation projects address multiple issues in a home. Ms. Moore advised that Home Repair is capped at \$18,000.00. Home Repair projects focus on smaller projects. Ms. Moore advised that the Homeowner Down Payment Assistance program is capped at \$65,000.00. This program provides assistance for low to moderate income families to provide a down payment for the purchase of a house. Ms. Moore advised that Habitat for Humanity is capped at \$30,000.00. for the CHIP program. Tenant Based Rental Assistance ranges from \$1,000.00 to \$3,000.00. Ms. Moore advised that the deadline to submit the grant is June 23, 2021. Commissioner Modranski asked if the cap is per home. Ms. Moore answered yes, the cap is for each home not for each program. Ms. Moore closed the first public hearing at 9:33 a.m.

IN THE MATTER OF

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

PUBLIC HEARING #1



Susan Moore, Community Development Specialist opened the first public hearing for PY21 Community Development Block Grant (CDBG) Program at 9:33 a.m. Ms. Moore advised that there are national objectives that CDBG projects need to meet. Ms. Moore advised that those objectives are Low- and Moderate-Income Benefit (determined by the Census and Income Survey), Direct Benefit, and Limited Clientele. Examples of limited clientele include abused children, domestic abuse victims or senior citizens. Prevention or elimination of slum and blight is also eligible for CDBG projects. Ms. Moore advised that an area that is blighted or a spot blight, one building that is hazard or eyesore is included. Ms. Moore advised that 2021 will be the last year for the CDBG Allocation Program. In

2023, CDBG programs will look different. Carroll County is eligible to apply for up to \$150,000.00. Ms. More advised that this covers the project, administration and fair housing. Carroll County can spend up to \$120,000.00 on a maximum of three projects. Ms. Moore advised that the change this year is taking away one project. Ms. Moore advised that resurfacing and paving projects are no longer eligible under the allocation program. Ms. Moore advised that these projects may be covered by the new transportation bill. Project applications are due to Tom Konst by May 6, 2021 by 3:00 p.m. After those applications have been reviewed and selected, the CDBG application is due to state by June 16, 2021. Ms. Moore advised that there are still several competitive grants and the firstround applications are June 16, 2021. A second round will be done for remaining funds. These grants include a Neighborhood Revitalization Grant in the amount of \$750,000.00 for project to improve the quality of life, livability and functionality of distressed areas and neighborhoods. Ms. Moore advised that resurfacing and paving are eligible in this grant, but it must be a distressed area or neighborhood. The Critical Infrastructure Grant in the amount of \$500,000.00 is for projects designed to assist communities with high-priority, single component projects, such as flood and sewer, structural road improvements and bridges. Ms. Moore advised that while resurfacing and paving are not eligible for the allocation grant, structural changes such as road widening are eligible for the allocation grant. Ms. Moore advised that Economic Development Loan program will be retained and is used to create jobs for low to moderate income persons, and is designed to create or retain jobs. The Economic Development Infrastructure Grant has the same goals as the Economic Development Infrastructure Grant. The Residential Public Infrastructure Grant is used to create safe and sanitary living environments though the provision of safe and reliable drinking water and proper disposal of sanitary waste. Ms. Moore advised that the Target of Opportunity Grant Program includes the Downtown Revitalization Grant in the amount of \$250,000.00, which is to improve Central Business Districts, aid in elimination of slum and blight, create and retain permanent private-sector job opportunities for low-to-moderate income households. These projects can include facade improvements, remediation of code violations and investment in streetscapes. Ms. Moore advised that up to three projects are allowed and business owners are expected to leverage funds. Ms. Moore advised that the Economic and Community Development Target of Opportunity Grant is for projects that don't fit other categories and are reviewed on a case-by-case basis. Ms. Moore advised that a lot of CARES act funding is being used through the Targets of Opportunity grant program so that the funding can get out to communities sooner. The New Horizons Fair Housing Assistance - Set Aside program is a \$15,000.00 grant to provide funds to affirmatively further fair housing and eliminate impediments to fair housing. Ms. Moore advised that the requirement for the fair housing grant is that after environmental review, it is determined that fair housing is in more need. The Ohio Housing Trust Fund Target of Opportunity provides funding for operations in permanent supportive housing and facility-based transitional housing programs for low to moderate income citizens. The Homelessness Target of Opportunity includes the Supportive Housing Program and Homeless Crisis Response Program. Ms. Moore advised that a Community Development Implementation Strategy meeting will be held on Thursday, April 22, 2021 at 7:00 p.m. via Zoom. This meeting will be for interested stakeholders to ask questions about the program. Ms. Moore advised that after the projects are selected, there will be a second public hearing to discuss the projects. Commissioner Wirkner stated that he is glad to see that there is some opportunity for road projects. Ms. Moore advised that the removal of paving and resurfacing was a last-minute change, however there is a public transportation opportunity coming up which may cover those projects. Public meeting closed at 9:48 a.m.
