Schaar, Clerk appeared before the Board to advise that the Community Development Block Grant (CDBG) Community Development Implementation Strategy (CDIS) meeting will be held tonight at 7:00 p.m. via Zoom. Ms. Schaar advised that Susan Moore, the grant administrator for Carroll County will attend the meeting to allow stakeholders to ask questions concerning the program and any projects that they may be considering. Anyone needing an invite to tonight's CDIS meeting should call Tom Konst at 330.627.5611. Ms. Schaar advised that she will post the information on Facebook. Ms. Schaar advised that Mr. Konst has mailed applications to all townships, villages, the county home, Fox Township Fire Department and other groups that have requested one.

IN THE MATTER OF **HEALTH DEPARTMENT COVID-19 UPDATE**



9:15 AM

Kelly Englehart, Director of Nursing and Population Health appeared before the Board to present the weekly COVID-19 update. Carroll County is currently at 2,014 cases since the beginning of the pandemic. 1,960 of those have recovered, 42 deaths, 54 active cases, and no outbreaks. April has 34 reported cases so far, down from 59 in March. Ms. Engelhart advised that there are four known variant strains that the Center for Disease Control (CDC) is currently monitoring. Coronavirus is similar to the influenza virus in that they typically mutate. The more ability that they have to spread, the more opportunistic the viruses are to change. Ms. Engelhart advised that the four mutations seen are UK, South African, Brazil, and two were identified in California as of February, 2021. They are currently circulating throughout the United States, including Ohio. Ms. Engelhart advised that the variant strains tend to spread more rapidly than the normal coronavirus; research is being done on the effects on treatments as well as testing and vaccinations. The CDC is showing that the vaccine does work and that antibodies that are made with the current licensed vaccine will protect against the variant strains. Symptoms present the same way as COVID symptoms. Ms. Engelhart advised that residents won't necessarily know that they have a variant, they will just know that they have tested positive. The only way variants are identified is when tests are sent to the Ohio Department of Health (ODH), who do more testing on the isolates. Symptom-wise, they present the same. For public health purposes, the variant strains spread more rapidly and that is why social distancing and mask wearing are still so important. Ms. Engelhart advised that vaccination rates are starting to decrease and Carroll County is currently at about 30% of the population vaccinated. To date, Carroll County Health Department has received a total of 9,400 doses since December. Ms. Engelhart advised that the Health Department has vaccinated 8,132 people. In March, the Health Department administered 3,480 doses, which includes first and second doses. Ms. Engelhart advised that her office is seeing a significant decrease of appointments in April. In March, the clinics averaged around 300 appointments and are now at 175. Ms. Engelhart advised her office is looking at changing their vaccination strategy. Through the middle of May, the Health Department will finish their mass vaccination clinics at Transit and Damascus Friends Church to complete the second doses. Then, using the community outreach approach, teams will be going out to areas where residents live, work and play to try to get the vaccine out. The Health Department is partnering with the Senior Friendship Center and Meals on Wheels to reach homebound seniors, as well as working with civic organizations and schools. Ms. Engelhart advised that her office will be trying to set up at sporting events to be where it's convenient for the younger population to get the vaccine. A vaccine clinic is open at the Health Department on Monday, Tuesday, and Thursday evenings from 1:00 p.m. to 7:00 p.m. Ms. Engelhart advised that beginning on Monday, April 26, 2021, appointments can be made by calling 330.627.4866, extension 1530 or call the scheduling line at 330.627.8928 or residents can register online with the ArmorVax app. Ms. Engelhart advised that the outreach method will require more planning but will include mobile teams and a team at the Health Department. Commissioner Wirkner advised that the Lake Mohawk Community offered the use of their facility. Jack Buettner can be contacted to make arrangements. Commissioner Wirkner advised that he has seen estimates that the variants are as much as 60% more transmissible as the original virus. Ms. Engelhart advised that she has seen where variants are widely circulating, the transmission can be that high. Ms. Engelhart advised that Michigan is currently the new epicenter for cases. Commissioner Wirkner advised that the severity of symptoms is stronger than the original. For those that are hesitating on getting the vaccine, they run the risk of contracting a variant strain with increased severity of symptoms. Ms. Engelhart advised that herd immunity is a long way away. Ms. Engelhart advised that Carroll County's hospitalization rate has increased. In March, the hospitalization rate was 1.69%, which was one hospitalization out of 59 cases. April is currently at four hospitalizations and only 34 cases. Melissa Schaar, Clerk advised that a resident on Facebook had a question. Ms. Schaar advised that Gayle Walker asked if the 30% vaccination rate included people from other vaccination sites such as pharmacies. Ms. Engelhart advised that vaccinations are reported to ODH by residency, so it will include all Carroll County residents, including individuals who may have been vaccinated outside of Carroll County. Commissioner Wirkner asked how Carroll County's vaccination rate compares to the nations data. Ms. Engelhart advised that she does not know the nation's current data, but Carroll County is lower than Ohio's current vaccination rate which is 39.9% and Carroll County is 29%. Ms. Engelhart advised that her office is reviewing the possible issues with vaccination strategies, a general hesitancy, or a possible saturation rate. Ms. Engelhart advised that an increase in spread may lead to an increase in variants and possible resistance to the vaccine.
