IN THE MATTER OF **HEALTH DEPARTMENT COVID-19 UPDATE**



9:04 AM

Kelly Engelhart, Director of Nursing and Population Health appeared before the Board to provide the monthly COVID-19 update. Ms. Engelhart advised that Carroll County had a total of 478 cases in the month of September. Of those cases, 41% were ages 21-49, 20% were ages 12-20, and 5.6% were under the age of 12. Ms. Engelhart advised there were 9 deaths in the month of September, and 90% of those who died were not vaccinated. Ms. Engelhart further advised that there have been 84 cases of COVID already reported for the month of October, and there have been 4 deaths in people ranging in age from 63-90, all were unvaccinated. Carroll County transmission level remains high with regards to COVID cases at 360 cases per 100,000. Ms. Engelhart advised that Carroll County's vaccination rate is 41.6% for first dose and 38.6% fully vaccinated individuals which is lagging the state of Ohio, currently reporting

50.5% fully vaccinated individuals. Ms. Engelhart does note that an increase in vaccinations for the month of September with 144 individuals receiving their first dose. Ms. Engelhart advised that they did give 12 booster shots of the Pfizer vaccine in the month of September to people who were eligible. Ms. Engelhart advised that currently there is only a booster vaccine available for Pfizer, and most individuals in Carroll County were vaccinated with the Moderna vaccine and will not be able to receive a booster until Moderna becomes approved through the FDA. Ms. Englehart advised that they tested 600 people for COVID in September, and 32% tested positive. They continue to do testing and administer vaccines Monday, Tuesday, Wednesday, and Friday from 9:00 am to 3:00 pm, and Thursdays from 9:00 am to 6:00 pm. Commissioner Wirkner shared an observation regarding the Health Department's rapid COVID testing. Commissioner Wirkner advised that his wife became ill, and they acquired a take home test from the Health Department. Commissioner Wirkner advised that it worked well taking about 20 minutes for the test process, and his wife tested negative for COVID-19. Commissioner Wirkner advised that his wife's doctor would not see her in the office until she had a negative test, and the test worked well for this purpose. Ms. Engelhart advised that she was pleased to hear that the home test was working well as they previously had reports that people were waiting over an hour to complete these tests at home with the downloadable app. Ms. Engelhart advised that they will continue to provide the home testing kits to individuals when they are not able to do the testing in person at the Health Department. Ms. Englehart advised that they will not be available for testing on Fridays while they prepare for their accreditation site visit. Ms. Englehart also advised that they will be closed on Monday, October 11th for Columbus Day, but individuals who are calling in today regarding COVID testing are being provided with home testing kits. Commissioner Wirkner advised that throughout the testing process with the home kits, the administrator who is conducting the telehealth appointment has to observe the test process so it may be necessary to have someone assist the individual taking the test.
