Amy Campbell, Office Administrator and Jessica Slater, Director of Nursing for the Carroll County Health Department appeared before the Board to give the weekly COVID update. Ms. Slater advised that there have been 384 cases reported for the month of December, and there are currently 287 active cases. There have been 13 deaths for the month of December. The deaths included 6 males and seven females of which four were vaccinated but no booster and nine were unvaccinated. Ms. Slater advised the three of the deceased residents had been in long-term care facilities. Ms. Slater advised that there are currently nine outbreaks: two at congregate living facilities, one at a church, four long-term care facilities, and two at daycares. Commissioner Wirkner advised that it has been brought to his attention that the at-home test kits that are being passed out at the courthouse are expired and the company refuses to proctor the test due to the expiration. Ms. Slater advised that the company has extended the expiration date by six months until February of 2022, but the company that proctors them is a third-party company. Ms. Slater advised that other counties are also having this problem, but the state is working to contact the third-party proctoring companies and advise them of the extension. Commissioner Wirkner asked what employees should do that use the tests but can't get proctored. Ms. Slater advised residents should self-report positive results to the Health Department. Ms. Campbell advised that the Health Department ordered 8,000 more tests but will only be receiving 5,400 tests due to the demand. This batch of tests will be like the over-the-counter tests and will not be proctored. Ms. Slater said there will be two tests per kit, and the kit will include instructions. Commissioner Wirkner asked if the Emergency Management Agency (EMA) will be doing the leg work to pick up the new order of kits. Ms. Campbell advised that the state will deliver the test kits. Ms. Slater advised that the last order was delivered by the state as well, but EMA helped unload the kits.
