

### Retreat History

The site of the present County Home was purchased for \$13,600 on July 6, 1867. An additional tract was acquired, making 365 acres, some of which have since been sold. The original building was built in 1937 with county funds and opened April 1, 1938, under the management of the Carroll County Commissioners. A bond issue enabled the county to renovate the original facility. A new building was completed in 1954, naming it the Carroll Golden Age Retreat in 1988. As of 1993, the facility has been supported by county tax levies and donations.

### Policy Statement

It is the Carroll Golden Age Retreat policy to recognize each individual's dignity and that each person is unique, created by God. Concern is shown for all facets (physical, emotional and spiritual) of the resident's life. Each individual is given the highest level of care possible, consistent with the rules and regulations governing Rest Homes in the State of Ohio and with all state and local laws. We believe that by providing a safe and loving environment, the resident is assisted in adjusting to communal living. It is also the desire of the County Board of Commissioners to provide a safe, warm and caring environment for our residents.

*Our goal is for this facility to truly be a retreat, an extension of one's own home.*

### Our Services

- Medical director available 24 hours per day and weekly home visits
- Full-time Director of Nursing with 24-hour licensed nurses providing intermediate-level care
- Contracts in place to offer in-home labs, x-rays, EKG and other diagnostic testing, podiatry care, mental health care, audiology, PT/OT up to 3 days a week, wound care, palliative and hospice care
- Full-time mobility aide providing daily exercise, motion and balance programs
- Scheduled specialty medical appointments accompanied by our staff or the family with transportation provided by Carroll County Transit
- Respite care available
- Emergency Medical Ambulance Service (charged to private insurance, Medicare or provided by County)

### Our Amenities

- Family-style dining with home-cooked meals and snacks
- Semi-private and private rooms
- Satellite TV, wifi access, phone, electric recliner, electric bed, bedside table and closet furnished in every room
- Hair salon and barber
- Office safe for money or valuables
- Multi-denominational worship services
- Picnics in on-site Pavilion
- Full-time activity director with full-time assistants providing various activities (see monthly activity calendar)
- Daily housekeeping, laundry and linen services
- Improved security and safety measures
- COVID-19 prevention plan
- Transportation provided or own vehicle permitted

### Admission Criteria

- 18 years old or older
- One year Carroll County resident  
*Out of county residents are charged a 10% surcharge for the first year only.*
- Completion of application with review and approval by the medical director
- File copies of POA, guardianship, DNR and other pertinent legal documents
- Annual tuberculin test
- Must not require skilled nursing care as attested to by our Director of Nursing or physician

### Rates

*Subject to Change*

**Base rate: \$2,600/month**

**Respite care: \$90/day; \$630/week**

- Possible additional charges:
  - Incontinence supplies: \$50/month (Family may supply with no additional fee)
  - Dietary supplies: \$50/month (Family may supply with no additional fee)
  - Medication and co-pays, doctor visits, therapy, and appliances
- Indigent County residents will continue to be provided for as wards of the County
- Veterans aid and attendance may supplement income
