Kelly Engelhart, Carroll County Health Commissioner appeared before the Board to provide the weekly COVID update. Ms. Engelhart advised that 332 positive cases have been reported to the Health Department for the month of January. Ms. Engelhart advised that is probably not a reliable number knowing that there are many home-testing kits that have been distributed in the county, and not everyone doing the home testing is reporting their results to the Health Department. Ms. Englehart advised that results can be reported through the Health Department's website or by calling the Health Department. Ms. Engelhart advised that with 332 cases, the county is already at 45% of cases that were reported for the whole month of December. Ms. Engelhart advised that they are seeing a significant increase in positive cases, which will most likely exceed December's numbers. December saw the highest peak of cases at 735 and 95% of reported cases are the Omicron variant. Ms. Engelhart advised that Carroll County currently reports that 45% of its individuals have started the vaccination and 20-30 individuals a day are getting vaccinated with their first dose. Ms. Englehart advised that the State Health Department is looking into funding to incentivize getting vaccinated by handing out gift cards, and Carroll County will be looking into that opportunity once state funds become available. Ms. Engelhart advised that Transit will be hosting a vaccine clinic available every Thursday for walk ins. Ms. Engelhart advised that the supply of home test kits has decreased, and manufacturers are unable to meet demand, so Carroll County is not receiving anymore test kits. The rapid test kits are being prioritized for schools and universities, and the Health Department is currently out of them for distribution. Ms. Engelhart advised that 30,000 test kits were distributed in the county since October. They are still doing testing at the Health Department with rapid testing, but the rapid tests are on back order, and the Health Department may need to return to the PCR test, which requires a 48 hour wait for results. Commissioner Wirkner asked what individuals should do if they need a negative COVID test to return to work. Ms. Engelhart advised they can call the Health Department, but she is encouraging employers to stop requiring a negative test to return to work. Ms. Engelhart explained that the virus may be present in the nasal passages and will show as positive even though they are not transmissible after the quarantine period. Nancy Schaar, Free Press Standard asked how many deaths there have been for January. Ms. Engelhart advised there have been 2 deaths.
