Kelly Engelhart, Carroll County Health Commissioner appeared before the Board to provide the weekly COVID update. Ms. Engelhart advised that there have been 786 cases reported so far for January. There have been seven deaths to date for January. Ms. Englehart advised that she is thankful that the death rate is down to significantly from 22 deaths in December. Carroll County's case rate per 100,000 is down from 849 per 100,000 last week, to 594 per 100,000 this week. The Health Department's positivity rate is also down from 32% last week, to 17% this week. Ms. Engelhart advised that the requests for testing at the Health Department have decreased significantly, as well. Testing is still available by appointment. Residents can call 330.627.4866, extension 1563 to schedule an appointment. Ms. Englehart advised that rapid PCR and antigen testing is available, as long as tests are available. Ms. Engelhart advised that the COVID vaccination clinic has been moved from Carroll County Transit back to the Health Department, due to lack of demand. Vaccination clinics will be held on Thursdays from 1:00 p.m. to 6:00 p.m. and all boosters and vaccines for ages five and up will be available. Ms. Engelhart advised that residents can schedule their vaccine appointment on the ArmorVax app, or by calling 330.627.4866, extension 1563. Walk-ins are welcome at the vaccination clinics. Omicron is affecting susceptible residents, particularly those that are unvaccinated, and those who have not had their booster. Ms. Engelhart advised that antibodies from the primary vaccine series wane over time, and a booster is necessary to provide more protection. Carroll County vaccination rate is currently at 45.8% started, and 42.5% completed. Ms. Englehart advised that more than 50% of individuals are eligible for their booster and have not received it. The Ohio Department of Health (ODH) has released updated guidance regarding contract tracing. Ms. Engelhart advised that her office is in agreement with the updated guidance and will be moving away from universal contract tracing, and moving to cluster contract tracing, where the focus will be on high-risks settings including long-term care facilities, shelters, and jails. Ms. Engelhart advised that her office is currently working through the procedure change. Ms. Engelhart advised that her office will continue to focus on vaccinations, as this is the best defense we have against COVID.

Schaar, Clerk appeared before the Board to share a message from Tonya Myers, Senior Citizens Friendship Center Director: "According to the Centers of Disease Control and Prevention, loneliness and social isolation in older adults are serious public health risks affecting a significant number of people in the United States and putting them at risk for dementia and other serious medical conditions. Social isolation can lead to loneliness in some people, while others can feel lonely without being socially isolated. Carroll County Council on Aging posted this message on the Facebook today: Not to confuse anyone, but after two days off due to road conditions this week, we are making the choice to brave the temps and deliver meals (Salisbury Steak) today. Our drivers felt our seniors really needed us after seeing them yesterday! They will be sent out in TEAMS for their safety! I would like to remind each and every one of you, that during this pandemic, your senior family, friends and neighbors are struggling! They may not tell you, but they are !!! They are very alone. Sometimes we are the only smile they see!!! I challenge you to PLEASE drop them a card, a bag of candy or a hot soup this weekend. You don't have to go in or stay long, just a smile brightens their entire day!!! We have a few driveways we still haven't been able to get through, but we are working on a plan.
