Commissioner Modranski advised that the Health Department is continuing to see a decline in reported COVID cases. January recorded our highest total of cases since the pandemic started with 830 reported COVID cases, and there were nine deaths in January. As of February 10, 2022 we have 67 reported COVID cases and three deaths. In January, the health department conducted 420 COVID tests with a 37.14% positivity rate and 258 COVID vaccines were given. The health department continues to offer COVID testing and vaccination by appointment. The Health Department currently does not have at-home test kits to provide to the community. Additional tests have been requested through the Ohio Department of Health. The Food and Drug Administration (FDA) has approved the Moderna vaccine. Both the Moderna and Pfizer vaccines are now FDA approved vaccines.
